I've just got off the phone with Mr. Brafford. I'm going to go ahead and handle his issue with DSS directly even though he is a senior. From his account, he contacted LGOA a few months ago on another matter and they referred him to the Trident AAA. The Trident AAA gave him some phone numbers for HUD affiliated organizations none of which was helpful. Then with his own issue he has tried the numbers DSS provided many many times and none of them are leading to a conversation with a person or even a working voicemail. He then tried to get Trident AAA to help with his DSS issue and they gave him the more unhelpful DSS phone numbers. This gentleman is a veteran and a senior I am not sending him through another phone tree to nowhere. There may be a real reason he lost his food stamps but someone needs to give him a clear answer.

As for the other issue a few months ago, I'm going to ask the LGOA staff what the assessment process is supposed to be for a homeless

senior and see if we can refer him to Trident.
