

**ORDER  
MODIFYING AGREEMENT**

This matter came before the Board of Dentistry (Board) on the Respondent's petition to modify a condition of the May 6, 2004, Agreement between the Board and Respondent such that he be allowed to prescribe non-scheduled drugs, particularly antibiotics.

Paragraph 1(h), found on page three of five of the Agreement, required the surrender of the Respondent's controlled substance registration and all rights to issue prescriptions for any and all legend and controlled substances, providing leave to reapply for a controlled substance registration within two (2) years of the effective date of the Agreement should the Respondent be "fully exonerated of any and all pending and addition [*sic*] charges relating" to the matter.

There are no criminal charges pending against the Respondent, and, weighing its role in protecting the public, the need for qualified practitioners, and the requirements of practice, the Board unanimously voted to grant the Respondent's petition.


**NOW, THEREFORE, IT IS ORDERED** that:
