Mr. R. M. Cooper, Director of the Research, Planning and Development Board, appeared before the Commission to explain his request for appropriation transfers.

Mr. Jesse T. Anderson, State Superintendent of Education, and Mr. P. C. Smith, Chief Accountant, appeared before the Commission requesting an allotment of \$7,800.00 from the Civil Contingent Fund to supplement the appropriation for attendance teachers for the fiscal year 1947-48. It was pointed out to the Commission that the general law providing for attendance teachers was for an appropriation to the respective counties based upon the number of its legislative delegation, which in the larger counties provided more money than was necessary to pay the salary of one such teacher, and that in these counties the excess funds were used to apply on the salary of a second attendance teacher; but that the appropriation for 1947-48 only provided a salary for one teacher in each of the counties. The amount requested

was to supplement the funds provided for the larger counties according to the terms of the original act. The Commission deferred action on this request.

According to the terms of Section 72 of the General Appropriation Act, the Commission authorized the State Auditor to approve revolving funds for the above institutions at the amounts agreed upon between him and the respective institutions, but not to exceed 10% of the total appropriation.

Mr. Flowden and the State Auditor were authorized to study the list of salaries submitted by the various departments and institutions for approval of the Budget Commission, and to make recommendations to the Commission thereon, at a meeting to be held on July 8th.

The Commission then adjourned.
