To the Honorable Nikki Haley,

Before he started college I begged him to go either to West Point, or The Citadel. He graduated from Thomas Heyward Academy May of 2013, and was 18 at the end of May.

After two years attending USC-B, he visited with a friend of his from THA, Brennen Flurry. Brennen is a student of The Citadel, and our neighbor. Zack came back from the campus smiling. "Mom, I'm going to go to the Citadel". I started laughing. Zack loves to "Get my Goat", so to speak. While on campus he met with a SC Army National Guard recruiter. He explained to Zack that to enter the Citadel as a 3rd year NOB, he would be required to join the Guard.

So this he did. He went to Fort Leonard Wood for basic and advanced training. He was asked to then go to the Ranger's training in GA. He declined the invitation. Zack graduated his training in March 2016. Before he could register for college, his unit was called up. He will be 22 on 31May 17. He does not return till Oct. 2017, missing the deadline for entrance to college. He will be 23 as a NOB.

I've been told that others in his unit filled out paperwork to go to college vs Cuba. Zack is extremely loyal stating, "They need me. I have to go".

I contacted the Citadel, and spoke to Major Shamus Gillin, (843) 225-3294. He was adamant that the recruiter did not tell Zack that he was required to join, in order to be a Nob, 3rd year. I explained that Brennen Flurry was a witness. MS. Halley, our son was lied to by the recruiter. My friend works for the DOD in Washington. She stated that the recruiter could be fired for that. I did not want that. He is married with children to support.

My request is that PFC Newton, be sent back in June, to have a month off. Then go to college in August 2017, not 2018. He could be called up again, which would put him at more of a disadvantage. He want's to serve. His desire is to work for Homeland Security, CIA.

I pray 5 times a day for the most important things in my heart. My nighttime prayer's includes all others.



Paul does have a good work ethic. He is ready to get to work. Paul want's to be again a productive member of

society.


