SECTION 1: The Minutes for the meeting of August 20, 1992; copies of which had been previously mailed to each member of the Commission were approved.

SECTION 1a: The Commission unanimously passed a motion approving monthly reports as published by the Department of activities for the months of June, July and August, 1992.

SECTION 2: The Commission unanimously passed a motion approving purchase orders issued for amount in excess of \$10,000.00 during the month of August 1992, as shown in the Appendix.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to extend the consultant services of Enwright Associates, Inc./T. Y. Lin International for final process of completing preliminary engineering services for the overpass over US 17 and SC 700 along Route SC 61 in Charleston County at an estimated cost of \$28,000.00, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 5 with DeLeuw Cather/LPA Group for joint venture multilaning of US Route 521 from Sumter to Georgetown at an estimated cost of \$564,000.00, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to enter into a Supplemental Agreement with Sverdrup Corporation for additional engineering services related to the Conway Bypass in Horry County at an estimated cost of \$2,000,000, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into a research agreement with Land Resources Conservation Commission to develop design curves for sediment and erosion control at an estimated cost of \$20,750.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with Clemson University to conduct an HPR study entitled "Review and Recommendations for Pavement Marking Materials" at an estimated cost of \$18,940.00, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the University of South Carolina to conduct a study entitled "The Application of SHRP Implementation - Asphalt Test Equipment" at an estimated cost of \$50,000.00, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to advertise and select a consulting/engineering firm for the purpose of entering into an agreement to provide engineering services to upgrade and widen S. C. Route 101 in Spartanburg County at an estimated cost of \$500,000.00, as shown in the Appendix.

SECTION 10: On motion of Commissioner Newsom, seconded by Commissioner McLeod, the Commission unanimously passed a motion to accept the State Highway Improvement Program, as shown presented to the Commission.

SECTION 11: The Commission unanimously passed a motion authorizing the Department to write off as uncollectible vehicle and driver services accounts totaling \$2,737.80, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a gratis quitclaim deed dated July 31, 1992 conveying approximately 1,400 SF of land in Aiken County to Maggie Johnson Gantt Lott, as shown in the Appendix.

SECTION 13: The Commission unanimously passed a motion accepting a report by the Department concerning the execution of a quitclaim deed dated August 28, 1992 conveying approximately 360 SF of land in Lexington County to Marilyn Bassfield for the consideration of \$150.00, as shown in the Appendix.

SECTION 14: The Commission unanimously passed a motion authorizing the award of a building contract to Excex Company, Inc. for the low bid the amount of \$143,463.00, as shown in the Appendix.

SECTION 15: The Commission unanimously passed a motion authorizing allocations of State Highway Funds for State Institutions, as shown in the Appendix.

SECTION 16: The Commission unanimously passed a motion accepting a report by the Department of right of way payments in the State Secondary "C" Construction Program for Beaufort, Berkeley, Charleston, Chesterfield, Edgefield, Florence and Hampton Counties, as shown in the Appendix.

WHEREAS, Hurricane Andrew struck Florida on August 23, 1992 with devastating effect causing extensive damage to the southern part of the state; and

WHEREAS, the State of South Carolina had experienced a similar disaster in 1989 and had received invaluable assistance from others; and

WHEREAS, South Carolina Department of Highways and Public Transportation was aware of the type of assistance, expertise, supplies and materials needed by the Florida Department of Transportation to respond to this emergency and the urgency of restoring transportation facilities; and

WHEREAS, South Carolina Department of Highways and Public Transportation and its employees were willing to assist Florida in their recovery efforts and on short notice thirty-one employees deployed to Florida to deliver supplies and materials and to assist in the restoration of highway and transportation facilities; and

WHEREAS, the South Carolina Highways and Public Transportation Commission, by this resolution does recognize and commend the South Carolina Department of Highways and Public Transportation and the employees who participated in this effort.

NOW, THEREFORE, BE IT RESOLVED that the South Carolina Department of Highways and Public Transportation Commission does hereby commend these employees of the South Carolina Department of Highways and Public Transportation for their personal sacrifice and outstanding work in assistance to the Florida Department of Transportation in the recovery efforts to restore their highway and transportation facilities.

BE IT FURTHER RESOLVED that a copy of this resolution be presented to each employee who participated in this effort.

SECTION 35: On motion of Commissioner Brooks, seconded by Commissioner Harvey, the Commission unanimously passed a motion accepting the Legislative Compliance Review Committee's report on the Department's Minority Goals Program as prepared by the State Reorganization Commission August 1992 and that the Department comply with the proposals set forth in the report except where new legislation or amendments to the Department's regulations are proposed. The Commission passed a further motion that Department staff consider the proposals and report back to the Executive Director on the advisability of the newly proposed legislation and/or amendments to the regulations for the Commission's consideration.

SECTION 36: On motion of Commissioner Harden, seconded by Commissioner Self, the Commission unanimously passed a motion approving the recommendations of the Public Affairs, Publications and F.O.I.A. Committee that the room previously used by the Highway Users Federation be returned to the Public Affairs Division to be used as video production space and that a van be assigned to the Public Affairs office for transporting audio-visual equipment.

It is anticipated that this study will be conducted under the Department's On-Call Agreement over an 18 month period at an approximate cost of \$50,000.00. Highway Planning and Research funds will be utilized to defray the cost of the study.

It is recommended that the Commission give approval for the Department to enter into this Agreement.
