

NOW COMES, **JIMMY A. RICHARDSON, II**, SOLICITOR FOR THE FIFTEENTH JUDICIAL CIRCUIT OF THE STATE OF SOUTH CAROLINA, AND CERTIFIES:

- A. That **Jonathan Stefan Vanderhorst** is the name of the person for whom extradition is asked and that it is requested that Sheriff Phillip Thompson of the Horry County Sheriff's Office and/or his lawful designee(s) be designated to act as Agent(s) for the State.
- B. That in his opinion of the undersigned the ends of public justice require that the fugitive named herein, be brought to this State at public expense for trial.
- C. That the undersigned believes that he has sufficient evidence to secure the conviction of Jonathan Stefan Vanderhorst.
- D. That the person named as Agent herein is a proper person, and said Agent has no private interest in the arrest of said fugitive.
- E. That there has been no former application for requisition for the said fugitive growing out of this or any other transaction.
- F. That Jonathan Stefan Vanderhorst, the accused is under criminal arrest in the State of North Carolina.
- G. That this application is not made for the purpose of enforcing the collection of a debt, or for any private purpose whatsoever, and if the requisition herein applied for be granted, the criminal proceedings shall not be used for any of said objects.
- H. The fugitive was arrested, was released, and has breached the conditions of bail. The crime of which the said fugitive stands charged is Assault & Battery by Mob, a violation of Section 16-03-0210(1), Code of Laws of South Carolina (1976), committed in Horry County, South Carolina, on or about the 23rd day December 2012.
- I. Such Fugitive has fled from the justice of this State.
- J. Such Fugitive has taken refuge in the State of North Carolina.
- K. Such Fugitive was present in this State at the time such crime was committed.
- L. Below is a brief statement of the circumstances of the crime committed by such Fugitive, and details of the subsequent breach of conditions of bail, bond, pardon, parole, probation, or failure to comply with the sentence of the court, or the circumstances of his escape if he did escape from confinement:

On or about December 23, 2012, the Defendant and two other suspects did commit the crime of Assault and Battery by Mob. While the victim was standing near her vehicle, the defendant and two other suspects ran from behind the victim's residence, grabbed hold of the victim and threw her to the ground. All three suspects took part in holding the victim to the ground not allowing her to leave. The Defendant held his hand over the victim's mouth to prevent her from screaming as one of the suspects struck the victim on the left side of her face.




