### Memorandum of Law

In our country people are sovereign and the Government cannot sever it's relationship to Them by taking away their citizenship.

Sherar vs Cullen, 481 F.2d 946 (1973)

A writing is ' void ab initio ' in the case of fraud in the inception, and it need not be formally rescinded as a prerequisite to right of avoidance .

Bonacci vs Massachusetts Bonding Ins. Co., (1943) 58 CA

Crime is contagious . If the Government becomes a law breaker, it breeds contempt for law; it invites every man to become a law unto himself ; it invites anarchy

Owen vs City of Independence .

when a citizen is attempting to enforce the Constitution as herein shown he is doing so " not for himself alone but also [ for others ] as a 'private attorney general ' vindicating a policy that [ Constitution writers ] considered of the highest priority .

Newman vs Peggie Park Enterprises, 390 U.S. 400; 88 S Ct 964, 966;

A Judge ceases to sit as Judicial Officer because the governing principle of administrative law provides that Courts are prohibited from substituting their evidence, testimony , record , arguments, and rationale for that of the agency . Additionally, Courts are prohibited from substituting their judgment for that of the Agency . Courts in administrative issues are prohibited from even listening to or hearing arguments, presentation, or rational .

ASIS vs U S, 568 F2d 284.

Any Judge that does not comply with his Oath to the Constitution of the United States wars against that Constitution and engages in acts in violation of the Supreme Law of the Land .

The Judge is engaged in acts of Treason.

The U S Supreme Court has stated that " no State Legislator or Executive or Judicial Officer can war against the Constitution without violating his Undertaking to Support It ."

Cooper vs Oconner, 99F.2d 133

Eleventh Amendment does not protect State Officials from claims for prospected relief when it is alleged that State Officials acted in Violation of Federal Law .

CORRUPTION OF AUTHORITY : Burton vs United States , 202 U. S. 344 26 S . Ct. 688 50 L. Ed 1057.

The claim and exercise of a Constitutional right cannot be converted into a crime, a denial of them would be a denial of due process of law. Warnock vs Pecos County Texas.

Where rights Secured by the Constitution are involved there can be no rule making or legislation which would abrogate them. Norton vs Shelby.
