**MOTION FOR A PRELIMINARY INJUNCTION**

Pursuant to Federal Rule of Civil Procedure 65(a), plaintiffs move for the entry of a preliminary injunction preserving the status quo by prohibiting the Defendants from manufacturing or issuing license plates imprinted with the words “I Believe” and a cross superimposed on a stained-glass window.

The grounds for this motion are that plaintiffs have a strong probability of success on the merits of their claims that DMV’s issuance of this license plate will violate the Establishment Clause and/or the Free Speech Clause of the First Amendment to the United States Constitution; that absent an injunction plaintiffs will suffer irreparable harm; that the requested injunction will

not injure defendants; and that the public interest supports granting the requested relief, all as shown more fully in the Memorandum of Points and Authorities filed herewith.
