SECTION 1: The Minutes for the meeting of March 16, 2006; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving the action of the Department related to roads in the State Highway Secondary System, as shown in detail in the Appendix

SECTION 5: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway lettings of March 14 and March 21, 2006, as shown in detail in the Appendix.

SECTION 6: Commissioner Jones reported for the Invitations and Resolutions Committee and made a motion for Commission approval for the following resolutions:

- Request of Abbeville County Delegation to name bridge that crosses the Saluda River on Highway 252 in Ware Shoals in honor of Senator William H. "Billy" O'Dell
- H4665 – Name the bridge that crosses the Little River along SC Highway 72 in Laurens County the "Patriots of the Little River Regiment Memorial Bridge"
- H4685 – Name the bridge in Berkeley County that forms the boundary between Lake Marion and Lake Moultrie along SC 45 the "Amos Nathaniel Rogers Bridge"
- H4821 – Name the portion of Highway S-26-139 (Cane Branch Road) in Horry County from its intersection with S-26-19 to its intersection with S-26-97 (Adrian Highway) the "Austin M. Enzor Memorial Highway"

The motion was seconded by Commissioner Harrell and passed unanimously. Copies of the resolutions are included in the Appendix.

SECTION 7: Commissioner Harrell reported for the Finance and Administration Committee and made a motion requesting Commission concurrence on the recommendation of the Committee to move forward with four Capital Improvement Projects, as shown in detail in the Appendix. The motion was seconded by Commissioner Truluck and passed unanimously.

SECTION 8: On motion of Commissioner Harrell, seconded by Commissioner Truluck, the Commission unanimously passed a motion approving the recommended 2006 Appropriations Bill and SAFETEA-LU Bill earmarks, as shown in detail in the Appendix.

SECTION 9: There being no further business to come before the Commission, the meeting was adjourned at 12:20 p.m.

Surplus Property Public Notice

April 20, 2006

In accordance with the State of South Carolina Statute 57-5-340, by this publication the Department is making public the Surplus Property Real Estate Transactions to the State Highway Commission. The following sheets include a breakdown of surplus property real estate transactions. These transactions may have resulted from negotiations with property owners during right of way acquisition, direct sales, settlement of a condemnation action, and/or corrective actions to previously reported sales.

1. File 40.847 / US Route 21/176/321 / Richland County / Second District

During construction of improvements on US Route 21/176/321 (Huger Street), under File 40.847 in Richland County, in the City of Columbia, the Department acquired right of way from Appliance Parts Company, Inc. by Title to Real Estate dated June 27, 1988 and from Carraway Enterprises, c/o Jack Carraway by Title to Real Estate dated June 27, 1988.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to the real estate consultant to market to the general public. The Grantee offered the highest acceptable offer above the appraised value. Therefore, a Quitclaim Deed for approximately 2.02 acres of land to CJAS, LLC was executed on February 23, 2006, in consideration of \$415,000.00.

2. File 23.540 / US Route 123 / Greenville County / Fourth District

During construction of improvements on US Route 123, under File 23.540 in Greenville County, in the City of Greenville, the Department acquired right of way for US Route 123, by Title to Real Estate from Viva McLeod Chiles dated January 6, 1966.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant to sell. This very small uneconomic parcel of land was offered to the adjacent property owners with the Grantee making the highest offer. Therefore, a Quitclaim Deed for approximately 0.03 of an acre of land to Saeid Ray S. Saharkhiz was executed on March 6, 2006, in consideration of \$1,000.00.

3. File 23.188A.1 / US Route 25 / Greenville County / Fourth District

During construction of improvements on SC Route 247, under Project Number 172-A, near Ware Place in Greenville County, the Department acquired right of way for SC Route 247, from I.P. Jordan by Deed to Right of Way dated October 11, 1929 and from O. R. Ware & Mrs. G. T. Ware by Condemnation dated November 26, 1929; also during construction of improvements on SC Route 8, under FAS Project Number 43-A, the Department acquired right of way for SC Route 8, from Miss Addie Jordan and Miss Cary Sue Jordan by Condemnation dated March 23, 1938.

The intersection of US Route 25, SC Route 8, and SC Route 247 was realigned under File 23.188A.1 leaving an area of old abandoned sections of SC Route 8 and SC Route 247. A request was received by the adjacent landowner asking the Department to relinquish an abandoned portion of SC Route 247. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.17 of an acre of land to John R. Hannon, Jr. was executed on March 6, 2006, in consideration of \$3,200.00.

4. File 40.786 / US Route 176 / Richland County / Second District

During construction of improvements on US Route 176, under File 40.786 (project not constructed) in Richland County, in the City of Columbia, the Department acquired right of way for US Route 76, by Title to Real Estate from Beatrice S. Stanley dated January 24, 1974.

In the Department efforts to liquidate its surplus inventory, the subject parcel was given to a real estate consultant. The property was marketed to the public with the Grantee making the highest offer. Therefore, a Quitclaim Deed for approximately 0.09 of an acre of land to Robert and Christopher Hinrichs was executed on February 15, 2006, in consideration of \$35,000.00.

5. File 28.561 / Road S-858 / Kershaw County / Fifth District

A request was received from the adjacent property owner's attorney asking the Department to Quitclaim a 16-foot strip of right of way to the adjacent property owner in order to clear his title due to an error made on a survey approximately twenty years earlier. The request was researched to determine if the Department had any interest in the 16 feet, which was shown on a plat as part of a 66-foot right of way. It was determined that the Department only had interest in a 50-foot right of way. Therefore, a Quitclaim Deed for approximately 0.11 of an acre of land to Peter H. Hellman was executed on March 14, 2006, in consideration of \$500.00.

6. File 23.342A / US Route 25 / Greenville County / Fourth District

During construction of improvements on US Route 25, under File 23.342A in Greenville County, near the City of Greenville, the Department acquired right of way for US Route 25, by Title to Real Estate from Herbert Dan Page, Linda Page Allen, and Diane Page McKinney dated June 22, 2004.

A request was received from the adjacent property owner asking the Department to sell a piece of possible surplus property. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.71 to R. H. DeShields, III was executed on March 6, 2006, in consideration of \$22,000.00.

7. File 4223.100B / SC Route 80 / Greenville County / Fourth District

During construction of improvements on SC Route 80, under File 4223.100B in Greenville County, near the City of Greenville, the Department acquired right of way for SC Route 80, by Title to Real Estate from Henry W. Hulseberg dated June 4, 2002.

A request was received by the District Three Right of Way Administrator from an adjacent property owner asking the Department to sell a small piece of right of way. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.32 of an acre of land to The Greenville-Spartanburg Airport District was executed on February 15, 2006, in consideration of \$5,000.00.

8. File 4223.100B / SC Route 80 / Spartanburg County / Fourth District

During construction of improvements on SC Route 80, under File 4223.100B in Spartanburg County, near the City of Greer, the Department acquired right of way for SC Route 80 by Title to Real Estate from Blake A. Shermaker dated May 29, 2002.

A request was received by the District Three Right of Way Administrator from an adjacent property owner asking the Department to sell a small piece of right of way. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 1.52 acres of land to The Greenville-Spartanburg Airport District was executed on February 15, 2006, in consideration of \$10,000.00.

9. File 26.836 / US Route 501 / Horry County / First District

During construction of improvements on US Route 501, under File 26.992 in Horry County, near the City of Myrtle Beach, the Department acquired right of way for US Route 501 under 26.836, by Title to Real Estate from N and B South Investment Company, a General Partnership dated September 17, 2001.

In the Department's efforts to liquidate its surplus inventory, the subject parcel was issued to a real estate consultant to be marketed. The property was marketed to the public with the Grantee making the highest acceptable offer. Therefore, a Quitclaim Deed for approximately 0.67 of an acre of land to Carlos S. Scheer was executed on February 15, 2006, in consideration of \$375,000.00.

10. File 23.248 / Road S-492 / Greenville County / Fourth District

During construction of improvements on Road S-492, under File No. 23.248 in Greenville County, near the City of Greenville, the Department acquired right of way for SC Route 14 by Title to Real Estate from Laura M. Green dated September 9, 1994.

A request was received from Old Mill Stream, LLC, the adjacent landowner, asking the Department to relinquish a portion of right of way along SC Route 14. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel could be sold under certain stipulations that must be met by the Grantee to protect the drainage issues. Therefore, a Quitclaim Deed for approximately 0.08 of an acre of land to Old Mill Stream, LLC was executed on March 27, 2006, in consideration of \$6,900.00

EXTENSION OF CONSTRUCTION CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work as follows:

LAURENS COUNTY: (Commissioners F. Hugh Atkins and Marion P. Carnell)

Contract of Oglesby Construction, Inc. - File Nos. 30.171B & 30.175B - extended to include an additional section of Project State CRS-CR30 (File Nos. 4751.135B & 4752.133B) extended to include pavement markings on S-67 and S-76 for 16.28 miles.

Estimated Cost of Extension \$ 67,751.98

LEXINGTON COUNTY: (Commissioner John N. Hardee)

Contract of U. S. Constructors, Inc. - File 32.145B - extended to include an additional section of Project FAP BST-COMB(018) (File No. 40.100C) extended to include demolition and removal of buildings located on Tracts 65, 66, 71, 72 and 74 located on Pond Drive and South Lake Drive.

Estimated Cost of Extension \$ 54,600.00

RICHLAND COUNTY: (Commissioner John N. Hardee)

Contract of Elderlee, Inc. - File No. 40.256B - extended to include an additional section of Project IM-GR40(001) (File No. 40.7705.01) extended to include placement of guardrail on I-20WB near mile marker 78 and also on S-2918 (Polo Road).

Estimated Cost of Extension \$123,649.75

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

Removal of Roads From State Highway Secondary System

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

1. Abandonment of Relocated Section of Highway
2. Deletions and Removal of Roads from State Secondary System - Roads may be deleted and removed from secondary system by exchanging for equal or less mileage or roads, which have a higher traffic importance. Ownership reverts to local government having jurisdiction (city or county). Approval of deletion or removal by local government is not required.
3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.
4. Court Order

Correction of Description of State Highways

The Department recommends Commission approval of the correction of the description of sections of State Highway previously added to the State Highway System. The description of roads currently in the State Highway Secondary System may be changed for relocation purposes, to revise the description of the termini to show what was actually constructed by contract, county line changes, or a change in the secondary road number.

Additions to State Highway Secondary System

The Department recommends Commission approval to add sections of road to the State Highway Secondary System for construction and maintenance. The Department may add roads to the State Highway Secondary System by request of the County Transportation Committees contingent on mileage being available under the current mileage cap. Roads may be added to the State Secondary System by the construction of a new roadway, accepting existing county/city roads into our Secondary System by the swap method, or by county line changes. Roads added to the State Highway System must be constructed to Department standards or reviewed for compliance with Department standards.

Rescind Action Adding Roads to State Highway Secondary System

The Department recommends the Commission rescind its previous actions adding roads to the State Highway Secondary System for construction and maintenance. The Department may rescind action on roads, which have not been constructed and formally accepted into the State Highway Secondary System. Roads may be rescinded due to right-of-way being unavailable, problems arising during construction, or funding issues.

Transfer of Road between Secondary and Primary Systems

The Department recommends Commission approval to transfer sections of road from the Secondary System to the Primary System, or vice versa. Pursuant to the provisions of Section 57-5-50 of the Code-of-Laws of South Carolina, 1976, the Commission may transfer any route or section of route from the state highway secondary system to the state highway primary system, or vice versa, when, in its judgment, such transfer is advisable to better serve the traveling public.

Detailed information concerning each of these requests is attached.
