Under this program Dr. Sugar will continue to monitor, advise and see patients as needed for the above program. Mr. Wes Lothary is the Certified Mental Health Counselor and Ms. Sherry Bramlett has replaced Natalie Wood for billing.

Dr. Sugar is on call 24/7 for all patients and for the Allied Professional if needed. Dr. Sugar will provide clinical support and review documentation to assure that services provided are appropriate and medically necessary to the patient.

Dr. Sugar will do an initial assessment for a patient within a week of initial treatment if the patient does not have a primary doctor referring the patient to the program.

Dr. Sugar will be on call 24/7 for the allied Professional to contact if needed for a patient. Dr. Sugar will provide clinical support and review documentation to assure that services provided are appropriate and medically necessary to the patient.

Dr. Sugar will do the initial assessment for a patient within a week of initial treatment if the patient does not have a primary doctor referring patient to the program.

A referral from another physician must include the following:

1. Office notes stating the need for counseling services.
2. A diagnosis made by the primary care physician
3. Individual and/or family counseling services being requested.
4. Must be signed by the primary care physician. (No stamped signatures).

To meet the requirements for Medicaid the following items:

3. Dr. Sugar will be available 24 hours/7 days per week for the counselor to contact in case of and emergency or crisis.
4. Dr. Sugar will assume all professional liability for services rendered by staff under his supervision.
5. All records will be copied and given to Dr. Sugar before any billing is completed for the day of service.
6. All staff will give copies of his/her credentials for Dr. Sugar to have on file.
7. Dr. Sugar will pay all salaries of allied professionals and other personnel involved with the program according to contract.

Allied Professional duties

1. The counselor will provide copies of the referrals and all notes prior to billing Medicaid.
2. The counselor will call and discuss any relevant issues that may arise with a patient.
3. If a patient does not have a primary care physician the counselor is required to notify Dr. Sugar and/or his office manager immediately to establish patient with the practice. If the patient requires a pediatrician the counselor will request a pediatrician to admit the patient to their practice and notify Dr. Sugar and/or office manager of which pediatrician the patient will be seeing for evaluation.
4. The counselor will keep complete and thorough notes whenever he/she is treating a patient.
5. If the counselor decides that the patient requires more treatment that he can offer, a consult to a psychiatrist will be given.
6. All phone calls must be documented.
7. If any amounts of monies are asked per Medicaid to be reimbursed the allied professionals and other personnel involved will reimburse Dr. Sugar the portion of funds associated with the items Medicaid requires reimbursement.

Billing Specialist Duties:

To Whom It May Concern:

I am a Licensed Professional Counselor in Seneca SC and I specialize in working with children and teenagers. I retired from Oconee Mental Health but decided that I still wanted to be able to help children so I started my own private counseling business. I work alongside Dr Darryl Sugar. Dr Sugar specializes in Nephrology and Internal medicine and most of his patient load is elderly people. We are asking for an exemption from Medicaid because we do not believe it is in the children's best interest if they must go to Dr Sugar's office for me to treat them. My office is located 5 minutes away from Dr Sugar's and he is always available by telephone should I need him. His clientele would not be receptive to children in the waiting room and I strongly feel that the children would be very uncomfortable in his office. My office is a very cozy setting. It is in a historical home in the downtown area and it does not have the medical office setting that most children are frightened of. I strive to provide the best possible care for the children because they are most important and in providing such care they must feel comfortable. I currently receive referrals from all Pediatric offices in this area along with many from family practitioners. Oconee Mental Health, DRS, & local schools also refer to me. There is a tremendous need in this county for counseling services. Currently Holly Partin is the only other counselor who has an exemption from Medicaid in Oconee County. She also sends referrals my way and we are supportive of one another because our main concern is the welfare of the children. Oconee Mental Health refers to me because of my expertise and because I can see the children sooner and more frequently. I am only able to meet with the children a certain number of times due to Medicaid's rules while Mental Health is granted an unlimited amount of visits with each child. Currently I can see each child for 12 visits per calendar year under Medicaid's rules. My hope is that we can work together and allow me to be able to continue giving the quality of care that I am known for. Dr. Sugar and I work very closely together even though we are not located in the same building. We must remember that the children are most important and that they should receive the best possible care that is available. I feel that the proper care can be best given in a comfortable, homelike setting and I provide that in my current office. Thank you very much for your help in this matter.
