NAMI conducted an online survey in 2015 with the main question being, "What do insurance beneficiaries experience when they seek mental health care?" Additionally, the report offers several recommendations regarding network adequacy, plan transparency, and covering out-of-network costs.

# From the Administration

## Administration for Community Living

### ACL Releases New FAQs for Long-Term Care Ombudsman Program

Last week ACL released a list of new frequently asked questions (FAQs) that pertain to the implementation of the Long-Term Care Ombudsman Program Final Rule, which became effective July 1, 2016. The new FAQs cover ombudsman authority to resolve complaints about the guardian or other representatives of a resident, conflicts of interest of supervisors, intake processes to handle inquiries, appropriateness of people conducting ombudsman program activities, ombudsman program staff with professional licensing requirements, and court orders to disclose ombudsman program information.

Of particular note for State agencies are the provisions pertaining to supervisory structure and conflict of interest. Specifically, ACL notes that it is not necessarily a conflict of interest for Ombudsman to report to a supervisor that supervises other agency staff with conflicting responsibilities, although States should work to the best of their ability to allow Ombudsman to fulfill his/her functions fully and to avoid situations in which conflicting oversight may impact LTC Ombudsman programs or services.

Thursday, December 1, 2016, was recognized as World AIDS Day. In recognition, the Centers for Medicare & Medicaid Services (CMS), in collaboration with the Centers for Disease Control and Prevention (CDC) and the Health Resources and Service Administration (HRSA) issued an Informational Bulletin to inform state Medicaid agencies about important advances in HIV prevention, care, and treatment that have occurred in the last five years. Additionally, the White House released a fact sheet in recognition of the day.

# Surgeon General

## Surgeon General's Report on Alcohol, Drugs, and Health

The U.S. Surgeon General released a report titled, "Facing Addiction in America: The Surgeon General's Report on Alcohol, Drugs, and Health." While prior Surgeon General's reports have discussed substance use disorders in certain contexts, the new Surgeon General's Report on Alcohol, Drugs, and Health is the first Surgeon General's Report to address substance use disorders and the wider range of health problems and consequences related to alcohol and drug misuse in the United States. This report explains the effects on the brain of alcohol and drugs and how misuse can become a disorder. It describes the evidence showing the effectiveness of prevention, treatment, and recovery policies and programs. The report also discusses opportunities to bring substance use disorder treatment and mainstream health care systems into alignment so that they can address a person's overall health. It also provides suggestions and recommendations for action that individuals, families, community leaders, law enforcement, health care professionals, policymakers, and researchers can take to prevent substance misuse and reduce its consequences.

## From Congress

### The House of Representatives

#### House Passes Major Prescription Drug Legislation with Medicaid and LTSS Provisions

On Wednesday, November 30th, the House of Representatives voted 392-26 to pass the "21st Century Cures Act," which would modernize the way that the Food and Drug Administration reviews and approves prescription drugs for use in the United States. The Cures legislation largely focuses on pharmaceuticals; however, the bill was combined with another piece of Legislation, The "Helping Families in Mental Health Crisis Reform Act of 2016," which includes some significant policies impacting Medicaid and LTSS. Notable provisions in the bill include:

- Requires Electronic Visit Verification (EVV) of Medicaid home health and personal care services, and reduces state FMAP for such services provided without EVV beginning in:
  - ○ 2019 for personal care services; and
  - ○ 2023 for home health services.
  - Allows children in inpatient psychiatric facilities (IMDs) to receive the full range of early and periodic screening, diagnostic, and treatment (EPSDT) services, effective in 2019;
  - Directs HHS to perform a study on Medicaid managed care and coverage of individuals in

- - institutions for mental diseases as allowed under the recent managed care final rule;
  - Modifies the requirement limiting Medicaid durable medical equipment (DME) payments to the corresponding Medicare rate to become effective in 2018 instead of 2019;
  - Increases and clarifies requirements for notification and exclusion of providers terminated in any state;
  - Requires states to publish a fee-for-service provider directory on their website; and
  - Modifies Medicaid supplemental needs trusts to allow individuals with disabilities under age 65 to establish their own trusts instead of requiring a parent, grandparent, legal guardian, or court to establish the trust.

The legislation will now go to the Senate, where it is expected to pass.

## From the President-Elect

### The Trump Administration

#### Formal Announcements Made for HHS Secretary and CMS Administrator

Two important positions in the incoming Trump administration were formally announced on Tuesday, November 29, 2016.

Representative Tom Price (R-GA) will be nominated for the HHS Secretary position and Seema Verma will be put forward for Administrator of CMS.

Representative Price currently serves as Chairman of the House Committee on the Budget as well as being a member of the House Ways and Means Committee. Rep. Price is a physician, having practiced as an orthopedic surgeon prior to his career in politics.

Price has been a fixture in conservative policy, including membership in the House Doctor and Tea Party Caucuses, as well as serving as the Chair of the Republican Study Committee in 2009-2010. Representative Price has introduced [comprehensive legislation](#) outlining his vision of an Affordable Care Act repeal and replace plan. The legislation proposed repealing the Affordable Care Act and replacing it with tax credits and health savings accounts. Notably, his legislation also allows individuals to opt out of public programs, such as Medicaid, Medicare, CHIP, Tri-Care, in order to receive these tax credits. His role as HHS administrator signals that the Trump administration will likely work with congress to pursue significant changes to the ACA, Medicare, and Medicaid programs.

Seema Verma is a health care consultant based in Indiana and the founder of [SVC Consulting](#). Ms. Verma has significant history and involvement with the Medicaid program, including playing a key role in developing several Medicaid 1115 demonstration waivers in Indiana, Michigan, and Iowa. Ms. Verma has also worked with Indiana around several LTSS and disability-related issues,

including the development of a 1915(i) proposal; the transition from 209(b) to 1634 eligibility determination processes (ie: from a state-determined methodology to having Social Security perform disability-related Medicaid determinations); and working on a comprehensive assessment and recommendations around the LTSS delivery system in Indiana.

AIRS is seeking workshops addressing the breadth of I&R service delivery.
