## **Minimum Wage will Increase in Four States Thanks to Ballot Initiatives**

On Election Day, voters in five states--Arizona, Colorado, Maine, South Dakota and Washington--weighed in on the minimum wage through ballot initiatives. All of the initiatives were approved except one: Voters in South Dakota rejected a measure that would roll back the minimum wage for workers under 18 from \$8.50 to \$7.50. That means that minimum wage earners in four states will see a raise in coming years.


