All,

Over the past two years we have changed contacts three times for the South Carolina Computer Matching and Privacy Protection Act, so I copied all of our past contacts to help foster more effective communication on this issue. *Even if you are no longer involved* in this area, I am asking for your cooperation if feasible.

To give a brief history on this agreement, South Carolina successfully obtained former Governor Mark Sanford's signature for the CMPPA renewal on August 24<sup>th</sup>, 2009 and we were able to obtain Governor Nikki Haley's signature for the CMPPA Recertification last spring on 4/20/2011.

Because of the terms provided in the CMPPA, we are in the process of obtaining renewals of each state's CMPPA. This document is drafted to be signed off at the office of Governor Nikki Haley. Based upon a conversation that Heather Dawkins had this morning with Jimmie Earley from CIO in South Carolina, there are some concerns about the agreement. I believe that a discussion involving our staff, past parties involved in the renewals/recertifications, and the current staff may be beneficial in resolving all concerns and questions.

This, if not resolved, could be potentially disastrous. *I am requesting a response from all parties by close of business on Thursday, April 26<sup>th</sup>.* Please let me know if you can be available for a call sometime within the next week.
