Legislature Wraps Up Before Scheduled End on June 5

The 2013-2014 regular legislative session is scheduled to end this Thursday, June 5.

With time running short, the General Assembly will be working to finish remaining bills on their calendars and the 2014-2015 budget. The legislature is expected to return to Columbia later this month to take up budget vetoes from the Governor.

Senate and House Conference Committee will meet at 2 p.m. on Tuesday, June 23, to discuss [S. 459](#) and reach a compromise on a statewide texting ban bill.

SC Department of Social Services (DSS) Oversight Committee is still scheduled to 8:30 a.m., Wednesday, June 3, in Gressette 207. The [agenda is available](#) and the meeting can be [viewed online](#). Director Lillian Koller was scheduled to testify but resigned yesterday, June 2.

S.C. Primary Elections Take Place on Tuesday, June 10

Voting to Determine Ballot for Nov. 4 General Election

Statewide primary elections will occur next Tuesday, June 10. Primaries for many statewide offices are scheduled: State Treasurer, Superintendent of Education, Lieutenant Governor, US Senate and US House of Representatives Districts 2, 3 and 6.

County level elections are also scheduled, including SC House of

Representatives, and many sheriffs and county council positions.

Public Meeting Scheduled for the Committee to Eliminate Child Abuse and Neglect Fatalities (CECANF)

The federal advisory committee established under Protect Our Kids Act of 2012, Public Law 112-275, will hold an open meeting in San Antonio, Texas, on Monday, June 2, and Tuesday, June 3.

Texas has had the highest number of child deaths in each of the past five years with 215 child fatalities in 2012 according to [Child Matreatment 2012 report](#).

CECANF was established to develop a national strategy and recommendations for reducing fatalities resulting from child abuse and neglect. The purpose of this meeting is for Commission members to gather detailed information and insight related to federal policy, research and practice associated with child abuse and neglect fatalities, with a practice focus on Texas.

The Commission will continue its public meetings in Tampa on July 10, and in Detroit on Aug. 28. Three additional meetings will be scheduled by the end of the year. Visit the Commission's new website for more information and how to participate in person or by conference call.
