Mr. Patterson,

I'm sure you are aware of the issues with the MPPR edits being applied by Molina to patients picked up by them who were previously managed under either Fee For Service Medicaid and/or one of the Medical Homes Networks. I am reaching out to those that might be able to give me specific guidance as to whether or not these edits are proper. Based on everything I have been able to research thus far these edits are not correct.

I was told by Molina employees that these edits are based on the attached documents, which specifically reference Medicare. Furthermore, in my opinion we are not providing "Multiple Procedures", given my understanding of these rules, should they actually apply (which I don't believe they do anyway). The MPPR

initiative as written clearly was not intended to mitigate cost except to the extent procedures are provided in addition to other procedures. I believe we are being cheated with the application of these edits to our claims.

If you would be so kind as to let me know what is happening at the State level with this issue I would greatly appreciate it. I am fairly tied up during the day with tax appointments, so if it's easier for you to reply via email that is certainly fine with me. Mrs. Drake, I just left a voice message for you. I'm sure you are busy so I will be as brief as possible. Our company is a private rehab provider of Physical, Occupational and Speech therapy services in South Carolina. We serve only Medicaid children under SCHIP, we provide no services to Medicare insured's. All of our patients are typically under 5 years of age. We primarily deliver our service either in the home, in a daycare, or some other form of their natural environment. Most of our children/patients have some type of developmental delay. We are a privately owned company, not affiliated with any Dr's office or other physician's group.

There is a new Managed Care Organization operating in South Carolina. The children that were previously covered by Medicaid Medical Homes Networks (100% of Fee For Service rates) have been switched to this new carrier. This new carrier is applying an edit to all of our claims, and their reasoning and documentation for applying such edits is attached. It is the CMS Multiple Procedure Payment Reduction for selected therapy services.

I have spoken to a couple of folks at SCDHHS, and they seem to indicate that their hands are tied, they cannot get involved with my issue/question. I have also spoken to a couple of people at SCDHHS who tell me that this edit is not appropriate unless applied to services that are secondary to another service provided by a Physician. This would not be the case in our situation.

The bottom line is that I am not familiar enough with this policy to be sure one way or another. I do know that no other carrier in SC applies these edits, and I need to determine how to know with certainty whether this is a correct application of these edits.



Please be aware that we received information today of Molina Healthcare's (Medicaid's new MCO's that went into effect January 1, 2014) policy regarding speech therapy services for developmentally delayed children.

It states that they will not cover speech therapy services unless there is a medical diagnosis like Down's Syndrome, cerebral palsy, or brain injury because speech therapy due to a developmental delay is considered educational in nature.

This obviously has ramifications for the state budget, as BabyNet service funds will need to be accessed to pay for denied claims by thousands of children that are now covered by Molina. Therefore, Access Therapies will be requesting BNPA's for all children who have Molina Healthcare (Medicaid MCO) before continuing or initiating speech therapy services, so that we may invoice BabyNet for services as a payor of last resort.

The Molina Policy is "Molina MCG-035 Speech Language Therapy for children with Developmental Language Delay". Please feel free to forward this information to other providers and/or agency administrators as Molina Healthcare has not been forthcoming in distributing this information to providers up until now, and it appears their policies differ greatly from other Medicaid MCO's and traditional fee for service policies for speech therapy in this state.

I have forwarded this e-mail to Jerri Davison with PANDA as well. Please be aware that we received information today of Molina Healthcare's (Medicaid's new MCO's that went into effect January 1, 2014) policy regarding speech therapy services for developmentally delayed children.

It states that they will not cover speech therapy services unless there is a medical diagnosis like Down's Syndrome, cerebral palsy, or brain injury because speech therapy due to a developmental delay is considered educational in nature.

This obviously has ramifications for the state budget, as BabyNet service funds will need to be accessed to pay for denied claims by thousands of children that are now covered by Molina. Therefore, Access Therapies will be requesting BNPA's for all children who have Molina Healthcare (Medicaid MCO) before continuing or initiating speech therapy services, so that we may invoice BabyNet for services as a payor of last resort.

The Molina Policy is "Molina MCG-035 Speech Language Therapy for children with Developmental Language Delay". Please feel free to forward this information to other providers and/or agency administrators as Molina Healthcare has not been forthcoming in distributing this information to providers up until now, and it appears their policies differ greatly from other Medicaid MCO's and traditional fee for service policies for speech therapy in this state.
