RE: Request of Attorney General Loretta E. Lynch for the right/permission to file a complaint with the U.S. Department of Justice as provided by 42 USC § 2000b

Dear Madam Attorney General Lynch:

(1). As citizens, and residents of the state of South Carolina, and of the United States, I Rayfield Grant, and my spokesperson Charles E. Grant, are currently being (by injunction) deprived of (by the state of South Carolina) or threatened (by the state of South Carolina) with the loss of our right to the equal protection of the laws, on account of our race, color, religion, or national origin, by being denied equal utilization of a public facility (the courthouse) which is owned, operated, or managed by or on behalf of the state of South Carolina or subdivision thereof.

(1a). Wherefore, I Rayfield Grant, and my spokesperson Charles E. Grant, are currently barred (by injunction) from equally utilizing the courthouse (a public facility which is owned, operated, or managed by or on behalf of the state of South Carolina or subdivision thereof) for due process of law, and the equal protection of the laws.

(1b). In an ongoing effort to file a complaint with the U.S. Department of Justice (a federal agency), I made a request of my U.S. Senator (Senator Tim Scott) for constituent assistance for filing a complaint with the U.S. Department of Justice (a federal agency).

(1c). I have been informed by Senator Scott's office, that, in order for me to receive assistance for gaining access to, and utilization of the U.S. Department of Justice (a federal agency), I would have to: (1) file a complaint with the U.S. Department of Justice, and, (2) notify his office (Senator Scott's Office) that the complaint has been filed with the U.S. Department of Justice (a federal agency). Then his office (Senator Scott's Office) would send a letter on my behalf to United States Department of Justice (a federal agency), to implement the complaint, and follow-up on the complaint.

(2). As citizens, and residents of the state of South Carolina, and of the United States, I Rayfield Grant, and my spokesperson Charles E. Grant, hereby respectfully request of you (Honorable Attorney General Loretta E. Lynch) as the Honorable Attorney General of the United States, that I be granted the right/permission to file a complaint with the U.S. Department of Justice, as provided by 42 USC § 2000b.

(2a). Wherefore, I may seek as provided by 42 USC § 2000b, the equal protection of the laws, so that I may recover the theft of an: (1) out-of-court settlement of \$18,060,743.00, with interest, (2) punitive damages, and (3) such other and further relief, that Honorable Judge Paula H. Thomas along with the consent of all appearing attorneys deemed necessary during an off-the-record/closed hearing that was held at the Horry County Courthouse in Conway, South Carolina.

(2b). Moreover, I may seek as provided by 42 USC § 2000b, the equal protection of the laws, so that I may recover (from the state of South Carolina) demanded damages (for deprivation of constitutional and civil rights by the state of South Carolina) of \$150,000,000,000.00 (One Hundred Fifty-Billion Dollars), and punitive damages, and such other and further relief as deemed necessary, to be granted/awarded, trebly, jointly and severally to Rayfield Grant, and to his spokesperson, Charles E. Grant.

(3). To further explain paragraphs 1, 1a, 2a and 2b above in more detail, I respectfully call your attention to copies of the unclassified witness affidavits, dated March 18, 24, and 31, 2016, which are in the custody of Mrs. Elizabeth Herlong Brogdon, Chief Counsel for South Carolina Judicial Merit Selection Commission's Office, located at: 1101 Pendleton Street, Gressette Senate Office Building, Room 104, Columbia, SC 29202, Telephone (803) 212-6623.
