<MSG>Hope you are doing well. I am in need of help and was told to contact you. I have a 7 month old son named Korbin. At 4 months of age he was diagnosed with Spastic Quadriplegic Cerebral Palsy, Epilepsy (seizures), Microcephaly (brain too small), Chromosome 3 deletion and failure to thrive. He just had surgery last week to insert a G tube directly into his stomach to help with his feedings. We have been in the hospital more then we have been at home. 7 hospital stays so far and they range from 3 days to 11 days. He also have numerous doctors that he sees on a weekly basis. My husband and I also has a 3 year old son that we are trying to give as much attention to as possible.

On April 30, 2013 I filed TEFRA Medicaid which is Medicaid for disabled children and I have yet to get a response back. I have hospital bills piling up and paying what I can, but it is starting to become very overwhelming. Korbin does have Blue Cross insurance which helps some. On August 10, 2013 the small community (Lugoff) that I live in is having a benefit singing for Korbin to help with some expenses. My husband and I are both working full time jobs when Korbin is not in the hospital to pays bills and make ends meet. We are not one to ever ask for help, but its starting to become too much for us. I was told by Medicaid that I had until the middle of August to know if Korbin would be accepted or denied. With his disabilities, I would hate to know that he could possibly be denied for Medicaid.

I am not sure if you will be able to help us speed the Medicaid process up or not but I thought it would not hurt to ask.

Thank you so very much for taking the time to read this and for being the great person that you are. You are a true blessing.
