Hello!

I'm a reporter with the Chillicothe Gazette in Chillicothe, OH. I spoke with Angela Robinson this week who is a Chillicothe resident working to get confirmation that her grandchildren are in foster care in York County South Carolina.

Children: 12-year-old Jeremi Lynch, 8-year-old Kaleah Lynch, and 7-year-old Jayonna Lynch. She is the maternal grandparent, her daughter is one of six women from the area who went missing or were found dead between 2014 and 2015, a case we've covered consistently here and was highlighted in an Investigation Discovery series "The Vanishing Women."

She said she started reaching out to people in attempts to get more information and seek custody of the children on July 20. Robinson said she has hired a South Carolina lawyer Nathan Sheldon to handle the case. She said the attorney

told her the children would be sent to Franklin County, OH but that has yet to happen. She was awarded temporary custody in the Ross County courts in July 27.

She claims the children were taken to SC by their father and left there. Robinson is now seeking custody.

Angela Robinson claims she received a letter from the Governor's office sometime since Oct. 21 in reference to her plight.

I'm looking to confirm if a letter was in fact sent from this office to Ms. Robinson and if the governor's office has any knowledge of the case, or whether the children are in fact in foster care?
