

Dear Ms. Forkner:


Thank you for attending the meeting on December 30th at Medical University of South Carolina regarding the above.

In response to your letter of January 2, 2009, regarding the Medically Complex Children's waiver, we are pleased to inform you the State has received approval for the administration and operation of the waiver program by the Centers of Medicaid and Medicare Services. With this approval we have begun the waiver implementation process and will initially focus on transitioning the children in the Charleston Medically Fragile Children's Program to the waiver program.

We realize the situation you are in concerning the funding of the Webb Center. However, we need to direct our attention to completing a timely and orderly transition, which may take several months to complete.
