I also spoke to Ms. Ruth Rush several times about my mother after their investigation, they say they found nothing wrong after all that I showed them. This is the second time one of the agencies have failed my mother when they are supposed to help them.

I went to DSS in Columbia on Bull Street and spoke with then about what was going on with my mother. They told me to contact one of the head supervisor Gwen Thompson. I spoke to Ms. Thompson and once again she directed me to Ms. Melissa Morrison, this is the third time my mother was failed by our government and by the system and the result of this is that my

mother was killed because our agencies failed to help her. You all allowed this to Happen. I say to Governor Nikki Haley and all of our senators and Legislators in SC How many more of our children, elderly people, mothers and fathers have to die. What will it take to get DSS, DHEC and any other Agencies that are supposed to help Children and the elderly in SC to be held accountable for their actions? People are being miss treated in these nursing homes, because our Agencies are failing us over and over again. I would appreciate your assistance in this matter Mr. Scott, Governor Nikki Haley and all our other Legislators in SC.
