Hello, Governor Haley

I will make my concern as informative and brief as possible. My 12 year old son Daniel Scipio II has Autism and ADHD. He was receiving SSI benefits of \$600+ per month and now that I am earning less than what I earned prior to returning to SC. Before, my salary was \$43,200. Currently, my salary at MUSC is \$30,750 annually. I received a letter saying that I was over paid benefits so they started reducing and eventually said they are going to stop benefits for a period of time. I clearly cannot afford an attorney, and have two other children 16 and 6. I am asking if there is another method of obtaining his benefits at the correct rate again. Please advise if you can assist me in this endeavor. If not can you advise on who can assist me?

Also, do you know any pro bono attorneys/private investigators who can assist me with my ex husband working under the table as a CDL truck driver to avoid child support garnishment? He pays \$143 per month total for three children and their needs exceed that tremendously. The reason he paid that is because he lied to the judge about his employment to avoid student loans, taxes, and to suppress and minimize his child support obligation. This is hurting his children and causing them to lack the things they need.



We plan to lower DANIEL A. SCIPIO II's monthly Supplemental Security Income (SSI) payment from \$76.87 to \$0.00 beginning December 2016. The amount will change because his other income increased.

We explain how we figured the monthly payment amount on the worksheet(s) at the end of this letter. The explanation shows how his income, other than any SSI payments, affects his SSI payment. His other income may include a portion of his parent's income. We include explanations only for months where payment amounts change.

He may be able to get SSI again as soon as January 2017 if his other income decreases. If you do not hear from us about this in the next 30 days, please contact our nearest office. If he cannot get a payment, we will be able to tell you why. And if you disagree with the decision, you can ask us to review it.

**Information Used In Making The Decision**

- He has monthly income which must be considered in figuring his eligibility as follows:
  - His other unearned income of \$95.34 for December 2016 on.
  - The estimated wages received by his parent of \$4,883.85 for December 2016.
- In deciding his SSI payment, we did not count \$543.32 of his parent's income for each month, beginning December 2016 as a living allowance for ineligible children.

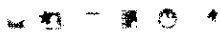

Since I live here and started a new job, I thought that transferring here and getting it modified was an option. The income would be reduced by more than 15% of what it was in NC and I now pay for health insurance, where there, my children had Medicaid.

I didn't ask them to modify it because I had the same job, income, insurance situation before leaving. When I arrived here my new job insurance situation is different. Since I am here now and can't take days off to go to court because of my lack of PTO and children, I was hoping to get it transferred which is what I was told when I called the call center.

The Case worker from NC is going to mail the court order and I will submit to you.

Yes, our office would require the order in order to review your case. Our office does not pursue unreimbursed medical bills. If the unreimbursed costs are court order from him to pay in your NC order, you will have to pursue this on your own or with a private attorney (this includes co-pays etc.).

I am not sure how the state of NC handles any issues regarding modification and how income is addressed.

Since you stated that Mr. Scipio is still in NC and your order is from NC, NC would have to modify your order there. Is your case still open in NC and are you receiving direct payments from their office? Why did you not ask them to modify your order directly if your case is still open?

- Do you need order in hand to proceed?
- My income has changed drastically, will the child support be modified?
- Will my ex husband be held responsible for any portion of the medical bills that I included in the fax? The reason why there is no coverage for my children is because SC Medicaid hasn't responded yet and my job didn't begin coverage until 9/1/16.
- Will my ex husband be responsible for any part of the co pays that I have had to pay?
- Will my ex husband be permitted to say he works for a day laborer company where he says he earns cash (which isn't true) to prevent garnishment?
- Is the calculator on the website accurate?
- If he quits his job (which he will most likely do), to avoid paying child support (his job at Emily Transport) will he still be required to pay?
- Do I need to submit anything else?
- Finally, he has an outstanding personal injury lawsuit, is it possible to present any calculated child support (imputed) against his settlement?

Just to let you know, this is in response to your email to [MSDAMISELA@YAHOO.Com](mailto:MSDAMISELA@YAHOO.Com). Due to something being wrong with the server in my phone, I cannot respond from it so I attached it.

I do have an order in NC, yes.

However my situation has changed. Please see the below:

1. I earn \$30, 750 annually (effective 8/22/2016) and am currently in SC. In NC I earned over \$43k.
2. In NC, my children had Medicaid. Here, I am paying for their health insurance.

I included everything I could in the mailed correspondence that was sent to the North Charleston office. It was faxed as well. This is per the instructions I got from a Customer Service Representative when I called SC child support services. I have a very dire situation and just want to stop being bounced from place to place and now ignored. All I want is a date in court since I live here, their father resides here as well and there needs to be a modification. Respectfully speaking, I don't see why I should have to go to NC to get this handled. I

My question is, why can I not get a call back? Why do I need to follow up with NC when I was told by the customer service representative that I needed to complete the application and send in the necessary information to SC?

Mrs. Johnson was very nice and left me a voicemail asking that either I provide the court docket number, or my social and confirming receipt of all of my information. I left her my social on the voicemail # she provided and haven't heard anything since.

So sorry for the long email. Please let me know what I need to do. Thank you.
