A regular meeting of the Anderson County Council was held on January 2, 1991 at 11:00 a.m. in the Anderson County Council Chambers. Chairman Mike Holden presided.

Vice Chairman David Hooper called the meeting to order and welcomed new member Bob Waldrep. Mr. Hooper gave the invocation. Everyone stood and pledged allegiance to the flag.

Mr. Hooper explained the first item of business was to elect a new chairman. He then nominated Ms. Cahaly and Mr. Holden seconded. Ms. Cahaly thanked them for the nomination but declined because of the new election coming up in March. Ms. Cahaly nominated Mr. Holden as Chairman and Mr. Banister seconded. Vote was four in favor and one abstention (Holden). Mr. Hooper relinquished the chair to the new Chairman. Mr. Holden nominated Mr. Hooper as vice chairman and Ms. Cahaly seconded. Vote was four in favor and one abstention. (Mr. Hooper) Mr. Holden thanked all members for their support as Chairman.

Ms. Cahaly moved to approve the December 13, 1990 minutes as mailed. Mr. Banister seconded and vote was four in favor and one abstention (Waldrep).

Mr. David Standeffer called for a public hearing for comments concerning Resolution #563. This resolution rescinds Resolutions #510 and #533 in their entirety and declares them null and void. On September 5, 1989 County Council approved Resolution #510, as requested by petition to extend the district boundaries of the Piedmont Sewer, Light and Fire District. Mr. Hooper moved to approve the Resolution and Mr. Banister seconded. Vote was unanimous.

Mr. Jack Crowe presented a request for Computer Services to purchase computer equipment from Inacomp Computer Center for the Anderson County Civic Center in the amount of \$3,124.80. Mr. Holden moved to allow the purchase and Ms. Cahaly seconded. Vote was unanimous.
