Trina,

The statute uses the word "must" when saying that county auditors "must" issue temporary plates "upon application" of a county resident. However, if a county office wants to ignore a state statute, we have no authority to do anything about it.

This is equivalent to the auditor's office not ordering any new temporary tags once they run out: there would be nothing we could do to make them order more.

This is a matter for County Council if the citizens complain that they want the auditor to do his or her job. Or maybe a new candidate will make it a campaign

issue in the next election.
