of my Son Roy M. Davis. He's in
Lee Correctional Institution in Bishopville, S.C.

He has been there for over 6 & 5 yrs.
He still has 4 more to go.

I'm writing to see if you can
Please Help me make his Prison Better.

My Son's been on Lock Down for
a couple months. He's suppose to be
Under Protection Care. He has been threatened
to be Raped and Killed by at least 6
Inmates. He was locked up in a
Room by his self, but the One's who's Threatening
him is locked up back there with him.

They Constantly Shake the Bars,
Hitting and then trying to Get him.

They say they can make a Key to
get into his cell, and I know for a
fact there has been Keys made there.

I Call the Prison Every day asking
them to Please move my Son to another
Prison but they say it has to go through
Classification. I Called the Warden and was
told to Call and they told me I
had to Call somewhere else. I've Called
and Called Every Warden I can find but
with No Luck! No One Seem To Care.

My Son is Really Afraid
for his life and ours. He was Threatened
and Our Family Was Too.

I've talked to Warren Davis and

Warden Stark. They Promised they
Would talk to my Son and He
Never Moved, but all that was a lie!!
I talked to Stark yesterday. He
was trying to tell him he's afraid and
my Son is afraid. He Promised he would.
So I told to my Son but He Never Did.
He Said my Son Was Safe where
he was but He's not. Then Supposed to
Leave the Yards in Jails locked at all
Times but they Don't!! Officers are
Supposed to Check on them Every day. They Don't!
When we were able to visit my Son
We Would Stand in Line for Hours.
Visitation on 1 day is from 8-5.
Sometimes we don't get in there till way
After 2:00. They have Count at 1 but
that's when Visitation Supposed to Start.
When we have to go through line to
Check our Clothes and be Patted Down
Usually there's Only 1 Cop Doing All of
This. it takes You Ever. They Need
More Officers helping but So We Can
Go See Who-Ever we're trying to see.
This is a Very Bad Prison.
The Don't Care about the Prisoners!
When I call trying to get
in touch with a Warden one who can
Sometimes I Call and the phone rings
Over 20 times & No-one Will Answer.
I Leave Voice Messages Bessing
SomeOne to Call me Back but They Don't

Can you "PLEASE" Help my Son
Get Transferred? also Around you
This Lie, Every Night al Way
Because He Locked Up in the Same
Sector the Elements are that are
Threaten Him. Every Night its the Same Lie.
They had a Power Outage last week
but Everyone has Power but my Son.
This Been Daily Power You Due a
Week - its Not Right Now This Been
Treated. Every Prisoner Should be Protected
in their, but lets Not what its Suppose
to Be - also Screened. Please, Please
Check onto this You Me. I Can't
Find anyone who Knows what Goes
On in His Prison. Please Help me!
