Lee Correctional Institute in Bishopville, S.C.
He has been there for over 6-8 yrs -
He still has 4 more to go.

I'm writing to see if you can
Please Help me make his Prison Better.

My Son's been on Lock-Down for
a couple months. He's suppose to be
under Protection Care. He has been threatened
to be Raped and Killed by at least 6
Inmates. He was locked up in a
Room by his-self, but the one's who's Threatening
him is locked up back there with him.

They constantly shake the Bars,
Hollering their Slog to Get Him.

They say They can make a Key to
get into his cell, and I know for a
fact there has been Keys made there.

I call the Prison Every day asking
them to Please move my Son to another
Prison but they say it has to go through
Classification. I called the number I was
told to call and they told me I
have to call somewhere else. I've called
and called Every Number I can give but
with No Luck! No-one seems to Care.

My Son is Really Afraid
for his life and Dads. He was Threatened
and Our Family was Too.

I've talked to Warren Davis and

Warden Shark. They Promised they
would talk to my Son and Let
him move, but all that was a Lie!!

I started to shout yesterday. I
was trying telling him when afraid and
my Son is afraid. He Promised he would.
So I came to my Son but He Never Did.

He said my Son was safe where
he was but he's not. Then Suppose to
leave the yops in doors locked and all
Tene's but they Don't!! 0 ypers are
Suppose to check on them everyday. They Don't!

When we were able to visit my Son
we would stand in line for hours.
Visitation on 1 day is from 1-5.

Sometimes we don't get in there till way
after 2:00. They have lunch at 1- but
that's when visitation Suppose to start.

When we have to go through line to
check our clothes and be patted down
usually there's only 1 cop doing all y
this. it takes for ever. They need
more 0 ypers helping out so we can
go ~~see~~ who. Ever we're say to see.

This is a Very Bad Prison.

They Don't Care about the Prisoners!

When I call trying to get
in touch with a Warden are who ever
Sometimes I call and the phone rings
over 20 times & no one will answer.

I leave voice messages begging
someone to call me back but They Don't

Can you PLEASE "Help my Son
get Transferred? also I would you
his Life. Every Night all way
because He's Locked-Up in the Same
Section the inmates are that are
Threats I don't. Every Night it's the same thing.
They had a Power outage last week
but Eugene has power but my Son.
He's been out of power you know a
Week - it's not right how He's been
Treated. Every Prisoner should be protected
in their, but it's not what it's suppose
to be - also Scared. Please, please
check into this you me. I can't
find anyone who knows what goes
on in this Prison. Please Help me!
