Reference: Parking Lot Issue – 3700 Landmark POD Location

When Garner Environmental Services, Inc.'s (Garner) corporate safety representative Henry Rocha arrived at the 3700 Landmark POD location on the morning of October 6, 2015 to wait for Garner's forklift operator, he noticed that the POD Management Team from the State of Florida was on site with 3 trailer loads of water. POD Management Team personnel stated to Mr. Rocha that the landing gear legs of two of the trailers had sunk into the parking lot asphalt and further noted there was not any cribbing under the landing gear legs.

Upon Mr. Rocha's arrival, Mr. Rocha also observed that one of the Florida POD Team personnel was operating the extended reach forklift, off-loading some of the pallets of water in order to make the trailer lighter, intending thereafter to try to lift the trailers to place cribbing under the landing gears legs for support. Once the Garner forklift operator, Spud Raven with 3R, was on site, he operated the Garner procured forklift and Henry Rocha off-loaded the trailers per the Task Order from the South Carolina Emergency Management Division to Garner. Mr. Rocha left the site at 1300 hours to go to the Lower Richlands POD site to await equipment coming from the Garner vendor for that site.

Garner equipment on this site was 1 - Pallet Jack, 2 - Portalets, 1 - Light Tower and 1 - Extended Reach Forklift, none of which are capable of causing the damages to the asphalt depicted in the attached pictures.
