Your Freedom of Information Act request dated April 18, 2012, was forwarded to my attention for handling. Enclosed please find a compact disc containing the documents responsive to your request for the contract between the South Carolina Department of Health and Human Services (SCDHHS) and LogistiCare Solutions, LLC, including the redacted proposal from LogistiCare Solutions, LLC related to the provision of non-emergency medical transportation brokerage services for Region 1 and the Emergency Contract entered into with LogistiCare Solutions, LLC for the provision of non-emergency medical transportation brokerage services for Regions 2 and 3.

The other piece of the contract documentation is the documents related to Solicitation 5400002201. As you will see, the emergency contract also incorporates these documents, including the original proposals of LogistiCare Solutions, LLC related to Regions 2 and 3. 
