The Plaintiff, PRO CAP II, LLC BY ITS CUSTODIAN US BANK, by way of this Complaint  
says:

1. The Plaintiff is the holder of the Certificate of Tax Sale, the details of which and the  
lands affected thereby are hereinafter more particularly set forth.

2. More than two years have elapsed since the sale of said lands pursuant to such certificate. Redemption thereof has not been made. There is due thereon the total amount thereof, together with interest, subsequent liens, and charges.

3. All municipal taxes and other municipal liens against the said lands and premises have been paid to the time of the commencement of this action and/or Plaintiff tenders itself ready and willing to pay all municipal liens asserted against said lands on and after the delinquency for which said tax sale or sales were held, up to and including the filing of this Complaint.

6. Upon entry of judgment in each count herein, the Plaintiff is entitled to possession of the property described therein. Defendants have, at all relevant times, deprived Plaintiff of such possession.

7. The Plaintiff repeats the allegations of paragraphs one (1) through six (6) first set forth above.

8. At a sale(s) of lands for unpaid municipal liens held by the tax collector of said municipality, under and by virtue of the provisions of the statute in such case made and provided, said sale(s) was/were conducted in all things according to the provisions of said statute, the lands

and premises hereinafter described were sold in fee simple subject to redemption to the purchaser named on such tax sale certificate(s), no one bidding at a lower rate of interest. The details of such properties, tax sale(s) and tax sale certificate(s) are set forth in the annexed schedule which is made a part hereof as if repeated at length.

9. After said tax sale(s), the Collector of Taxes made, executed and delivered to the purchaser a certificate(s) of sale pursuant to law, which certificate(s) was/were duly recorded in the Office of the Clerk/Register in the County where the property is situate.

10. The record owner of the lands and premises is/are RICHARD F. WILSON his heirs, devisees, and personal representatives and their or any of their successors in right title and interest and such owner(s) is/are named as proper party Defendant(s) to this action to foreclose his/her/their interest, and that of his/her/their successors, in the land and premises described in this Count of the Complaint.

11. The following persons are also proper party Defendants to this action for the reasons described:

a. MRS. WILSON, spouse of Richard F. Wilson is joined as a party defendant to this action for any right, title, interest or claim he/she, his/her heirs or successors may have in or to the subject property by virtue of dower, curtesy, inheritance or for any other reason.

b. WILMINGTON SAVINGS FUND SOCIETY, FSB d/b/a Christiana Trust, not in its individual capacity, but solely as trustee for BCAT 2015-14BTT is a defendant to this action because he/she/it is the current holder of the following instrument, to wit, a mortgage executed in favor of Fleet National Bank by Richard F. Wilson on July 2, 2004 and recorded on October 11, 2004 at mortgage book 08792, page 0128, in the principal amount of \$100,000.00. Most recent assignment recorded on November 18, 2015 at book 1173, page 378.

c. STATE OF NEW JERSEY is joined as a party defendant to the within foreclosure proceeding by virtue of possible inheritance taxes due in the Estate of Richard F. Wilson. Upon information and belief, Richard F. Wilson died September 4, 2013 a resident of the Township of Ewing, County of Mercer, State of New Jersey.

d. STATE OF NEW JERSEY is joined as a party defendant to the within foreclosure proceeding by virtue of any escheat interest in the subject property as described in the Complaint.


D. That Plaintiff be vested with an absolute and indefeasible estate of inheritance in fee simple in said lands and premises.


