**Note:** Though the justices, by a 5-4 margin, ruled the landmark law constitutional, they struck down its requirement for states to raise the eligibility income for Medicaid. That allowed South Carolina — as in Gov. Nikki Haley and the General Assembly — to opt out of the change.
