That focus helps us focus. I have some good news reference a group named "8 days of Hope" sponsored by Pfizer and the NFL. We believe they will come down and spend exactly 8 days working "Fast Track" projects with 3500 volunteers. The "Fast Track" criteria are good -- income under \$30K, over 65 years old or access / functional needs dependent. They are completely self-funded, so they will have an immediate impact on recovery. They are currently working with IA to identify the target audience.

Will also work to identify our building supply requirements list with the VOADs who are providing most of the labor for these building projects.

One more thing – I did not realize that Mayor Nelson was a state employee. She asked me if she could join our team if she could get a release from her boss. I told her that I would immediately place her in my “current operations” shop to start working and tracking “immediate requests” (a function we are trying to establish beyond our call / referral center).

We need to capture them before they leave thinking the work is done. We should also request across the state teams of 20 with 1 team leader that will be assigned an area of the state that needs help. This will allow our churches, Rotary, Kiwanis, Chambers, etc to get involved in helping their neighbors. My focus will be to keep full inventory of all building supplies needed by working the phones for supply or monetary donations.

Rebuilding is one of the quickest needs we have. i'm going to make sure Cheryl is very focused on the jobs front in these areas to get everyone back up and working.

Can't is not an option. We need to rebuild on our terms not on anyone else's.
