

1. Loans to Kershaw County.

Two loans are held by the Sinking Fund in the amount of \$300,000.00 and \$750,000.00. The county can meet its payment schedule on the \$300,000.00 note, but the Tax Reassessment Program will not be in full effect until the fall of 1968. The County Council requests permission to pay the interest on the \$750,000.00 note through August, 1967, with a second payment not due until January 10, 1969, and that the maturity of the note be extended to January 10, and annually thereafter for five years.

It is recommended that the Board approve this request.

2. Surplus Property Program.

The operating loss for April, 1967, was \$1,888.54. In May there was an operating profit of \$2,341.60, resulting in an eleven-month operating deficit of \$25,374.72. In order that the Revolving Fund not be impaired, it is recommended that the General Fund be reimbursed in the amount of the total fees received during fiscal 1966-67, thereby absorbing the deficit.

3. Purchase of Vehicles.

A. South Carolina Retarded Children's Rehabilitation Center.

A request has been received for purchase of a Pontiac Bonneville 4-door hard top for the Director and for the additional vehicle which is to be a Step Van equipped to transport small groups of passengers for clinic and recreational activities located away from the center. A 1965 Star Chief with 48,000 miles would be retained for use of other staff members.

It is recommended that the Board approve exchange for a like model of the Pontiac Sedan and that approval be granted for the purchase of the Step Van.

B. Medical College of South Carolina.

Requests exchange of 1965 Ford Galaxie for 1967 Lincoln Continental for the President. (Information: President of U. S. C., model 62 Cadillac; Chief Highway Commissioner, Chrysler Crown Imperial; President of Clemson, Oldsmobile 98; Department of Corrections, Chrysler New Yorker; President of Winthrop, Buick; Industrial Commission, Chrysler - Buick - Pontiac).

C. South Carolina State College.

1967 Buick Electra for Acting President.

4. Real Estate.

*O. Kelly*  
A. The State Employees' Association owns three (3) lots measuring 175 feet on Senate Street and 150 feet on Pickens Street. The Chairman of the Property Committee is offering these lots for sale. Although no price was indicated, it is understood that they are asking \$135,000.00.

It is recommended that the Board take appropriate action on this information.

B. McElveen Realty Company has a prospective purchaser for a 12 acre tract of State property at the Airport.

It is recommended that the Board take appropriate action on this information.

5. Renovations at State House.

✓ Final statement for renovations to the Capitol are attached. Total costs are within the amounts made available for the work, and it is recommended that the Board approve the indicated changes and additions.

6. Space for Department of Education.

✓ Space will be required for six professional staff members about July 1-15. Mr. Busbee requests consideration be given to moving a smaller agency to a new location in rented quarters in order that his staff will not be further divided.

It is recommended that action be taken to relocate an agency from the Rutledge Building.

7. Board approval of renting or leasing office space in Columbia area.

The University requests relief from this requirement in the Appropriations Act.

It is recommended that the University be authorized to act in behalf of the Board in leasing office space for University use.

8. Concession Stand-Hampton Building.

The Commission for the Blind requests that a portion of the space in the Hampton Building being vacated by the Tourism Unit be assigned for use as a concession stand.

It is recommended that the request be approved if the space is not required by any of the newly created agencies.

9. WIS Property.

X The State has been approached tentatively about possible purchase of this property at a price upwards of \$500,000. Educational TV Director Henry Cauthen reports that the property would not adequately house his Department.

It is recommended that any offer of the property be declined in favor of designing and providing State-owned space to meet specific needs of the agencies.


At the time I told you that Utah and Ohio both had extended invitations and you can see from the enclosed that Utah has gone to work on our executive committee.

Subject: Purchasing Unit

It has come to my attention that State Purchasing Agent Hugh White has transmitted a request to Board Secretary P. C. Smith that the Purchasing Unit be restored to its former Division Status. The incident which apparently precipitated this request is as follows:

On May 17, I was asked to meet in the Governor's Office at 10 a.m. on May 18, for a discussion with officials of Smith-Corona Company regarding purchasing practices for office machines. On that day I called Mr. White, asking him to accompany me. Mr. White reports that he understood the meeting was set for 10:30, however, on the morning of the meeting, I called Mr. White about 9 o'clock asking that he come by my office at 9:45 so we could go to the meeting together. At about 9:52 I called Mr. White's office and asked the young lady on the line to "tell Mr. White to come on." About 9:56 Mr. White had not appeared, so I went to the State House alone, and Mr. White joined us some fifteen minutes later. The young lady was upset by my abrupt request, and I have apologized to her personally for this lapse of decorum. Mr. White felt that this was a public reprimand which could not be accepted without some action on his part.

When asked if it were true that he had requested transfer of Purchasing from the Division, Mr. White agreed that it was, but he did not have a copy of his request for me. At this point we began a discussion of the matter, starting with the situation outlined above. We had a frank talk about the problems which were inherent in combining formerly independent units into a new Division with new lines of authority, and the natural resistance to such a change. Mr. White said he felt I was unbending and dictatorial, and I confessed I had found him incommunicative, uncooperative and resistant. The discussion reflected a lack of communication on both sides, and if such a confrontation could have occurred at

any time up to the present, I am certain the results would have been satisfactory. I have talked frequently with Mr. White and tried to draw him out and get him to "open-up" and say what he had on his mind, and this has been without success until yesterday.


The Purchasing Unit is doing a fairly adequate and competent job, but there is much room for improvement which has been apparent since the Pinson Report was made several years ago. Some \$20 million in purchases are now, and have been made directly by the using agencies. The average invoice has been around \$500, with some commodity totals reading about \$1 million a year.

We have accumulated statistical data for two years to indicate the commodities and annual quantities in an effort of securing combined orders, periodic contracts or some other arrangement to effect quantity purchase discounts. This has been discussed with Mr. White from time to time. No significant progress has been made in this direction, although Mr. White has had in mind establishment of a "Standards Committee" to assist him in working out details of such a plan. Some three months have gone by without activation of such a group.

A standards committee did operate for a short while in 1964, and was successful in establishing procedures for periodic buying of paper products and janitorial supplies.

We have seven purchasing assistants who are burdened with unnecessary detail of "shopping" for small orders. Most states have automated procedures to eliminate such routine work and to allow time for more productive work by technical personnel. This procedure has been discussed with Mr. White over a period of time, yet no significant progress has been made in this direction.

In view of the lack of understanding which has existed, it is recommended that Mr. White be permitted to retain his position in the Division of General Services, and that he and the Director work more closely together in policy and procedural matters to effect more efficient methods of operation to carry out policies approved by the Budget and Control Board.


Dear Mr. Smith:

THE STATE OF SOUTH CAROLINA.

WHEREAS, Whitten Village, by and through its Board of Trustees (the Trustees) has presented an application to the State Budget and Control Board of the State of South Carolina (the Board) for the sum of Five Hundred Thousand Dollars (\$500,000) to pay the cost of constructing additional facilities at Whitten Village; and

WHEREAS, the Board has considered said application and has, for itself, obtained the information needed to make the findings hereinafter made,

NOW, THEREFORE, BE IT RESOLVED BY THE STATE BUDGET AND CONTROL BOARD OF THE STATE OF SOUTH CAROLINA, AS FOLLOWS:

I.

The Board has ascertained, and hereby determines that a definite and immediate need exists for the improvements described in the application made on behalf of Whitten Village as follows: to construct additional mental health facilities at Whitten Village, and that the application therefor should be approved.

II.

That the fees collected from paying patients at Whitten Village calculated both on the basis of the preceding 12-month period, as contemplated by Paragraph 3 of Section 1 of Act 1100 of the Acts of the General Assembly of the State of South Carolina, entitled "AN ACT TO AUTHORIZE THE ISSUANCE OF NOTES OR BONDS FOR MENTAL HEALTH FACILITIES; TO PRESCRIBE THE CONDITIONS UNDER WHICH THEY MAY BE ISSUED; TO PROVIDE FOR INVESTMENTS IN SUCH NOTES OR BONDS; AND TO PROVIDE FOR THEIR PAYMENT," Approved the 20th day of April, 1964 (Act 1100), and on the basis of the available number of patients for the preceding 3-year period as contemplated by Section 4 of Act 1100, were as follows:

Such estimated revenues, based both on the basis of the fees collected during the preceding 12-month period contemplated by Paragraph 3 of Section 1 of Act 1100, and on the basis of the preceding 3-year period, contemplated by Section 4 of Act 1100, will, if multiplied by the number of years for which the Notes herein provided shall be outstanding, result in the production of a sum equal to not less than one hundred twenty-five per cent (125%) of the estimated aggregate principal and interest requirements of all Notes or Bonds now outstanding and now proposed to be issued for said Institution upon the approval of such application.

III.

The Board hereby approves such application and shall transmit to the Governor and State Treasurer a request for the issuance of Notes to the extent of \$500,000 on behalf of Whitten Village and in order to comply with the provisions of Section 3 of Act 1100 sets forth the following information:

1. The name of the Institution seeking funds and the amount sought on the basis of the application filed with the Board is as follows:

WHITTEN VILLAGE            \$500,000.

2. The Board has made all findings required of it by Section 2 of Act 1100 and has not modified in any way the application made on behalf of Whitten Village.

3. The proposed maturity schedule of the Notes is as set forth in Schedule I of Exhibit A attached to the application.

4. The anticipated interest cost for each year during the life of the Notes and the anticipated aggregate principal and interest requirements for the Notes are set out in full in Schedule I of Exhibit A attached to the application of the Trustees of Whitten Village.

5. It is proposed that the Notes to be issued be subject to redemption on any interest payment date after December 1, 1967, in the inverse chronological order of the maturities of the principal installments, and in multiples of \$10,000, at a redemption price equal to the par value of the principal amount so redeemed and accrued interest to the date fixed for redemption.

6. The number of paying patients at Whitten Village at the time of application and the revenue derived therefrom during the preceding 12-month period were as follows:

IV.

State Institution Notes in the aggregate principal amount of \$500,000 should be issued as a single issue. Such issue shall consist of a single fully registered Note, more fully described as follows:

\$500,000 Whitten Village Note, Series of June 1, 1967, dated as of the first day of June, 1967, payable in twenty (20) equal annual installments as follows: \$25,000 on June 1 in each of the years 1968 to 1987, inclusive, bearing interest at the rate of five and one-half per centum (5-1/2%) per annum, from the date of delivery thereof (as established by the certification endorsed thereon), payable on June 1 and December 1 of each year, commencing December 1, 1967. Both principal and interest are payable in legal tender by check or draft issued by the State Treasurer of the State of South Carolina to the registered holder of the Note.

The form of said fully registered Note shall be substantially as set forth in Exhibit B attached hereto.

The State of South Carolina reserves the right to effect the prepayment, on any interest payment date after December 1, 1967, of any portion of the indebtedness evidenced by said Whitten Village Note, Series of June 1, 1967, that it may determine upon, in the inverse chronological order of the maturities of the principal installments, and in multiples of \$10,000, at a redemption price equal to the par value of the principal amount so redeemed and accrued interest to the date fixed for redemption.

If the option to redeem shall be exercised, notice of redemption shall be given to the holder of said registered Note at least thirty (30) days prior to the prepayment date, by mailing to such holder a notice prescribing such prepayment date and specifying the amount of principal to be prepaid.

Payment of interest and installments of principal of said Note, and portions thereof (if the privilege of redemption be exercised), shall be effected by check or draft drawn by the State Treasurer to the order of the registered holder. All payments of principal and interest shall be duly endorsed upon the Payment Record appended to said Registered Note.

V.

Said Registered Note shall be executed on behalf of the State of South Carolina by the Governor and State Treasurer. The Great Seal of the State of South Carolina shall be affixed thereto and the same shall be attested by the Secretary of State.

VI.

Pursuant to the authorization of Section 13 of Act 1100, the Board approves the private placement of the Note hereby authorized to be issued, to bear interest at the rate of

five and one-half per centum (5-1/2%) per annum, from the date of the delivery of the Note (as established by the certification endorsed thereon), payable on June 1 and December 1 of each year, commencing December 1, 1967. Such Registered Note shall be sold to the State Budget and Control Board of South Carolina, as Trustee of the funds of the South Carolina Retirement System.

VII.

For the payment of the principal of and interest on the Notes herein authorized, there shall be pledged the revenues derived from paying patients at Whitten Village and so much of the revenue derived by the State of South Carolina from inheritances, gifts, or estate taxes as may be necessary to meet the annual principal and interest requirements of said Notes.

VIII.

The State Budget and Control Board, in its capacity as the owner and holder of all Notes heretofore issued for Whitten Village hereby consents that the Notes issued pursuant to this Resolution shall be on a parity in all respects with the Notes heretofore issued for Whitten Village and the State Hospital, as well as on a parity with all other Notes hereafter to be issued for Whitten Village; and the State Treasurer is hereby authorized and empowered to place upon the face of all of said Notes heretofore issued a written statement evidencing this action.

IX.

The pledge of the revenues derived by the State of South Carolina from taxes imposed upon inheritances, gifts and the estates of deceased persons, herein made to additionally secure the Whitten Village Notes, Series of June 1, 1967, shall not be deemed closed, and obligations may hereafter be issued

by the State of South Carolina (if authorized by appropriate legislative enactment) secured in whole or in part by a pledge of the revenues derived by the State of South Carolina from taxes levied upon inheritances, gifts and the estates of deceased persons, on a parity in all respects with the pledges made to additionally secure obligations issued or to be issued for Whitten Village.

X.

A certified copy of this Resolution shall be transmitted to each of the State Governor and the State Treasurer who shall, if they make the findings prescribed by Section 4 of Act 1100, approve this request and thereafter effect the issuance of the Notes herewith requested.

In addition to the installments of principal required to be paid as hereinabove set forth, the right is reserved to the State of South Carolina to prepay on June 1, 1968, and all subsequent interest payment dates, installments of principal in inverse chronological order, and in multiples of \$10,000 and at a redemption price equal to the par value of the principal amount so redeemed and accrued interest to the date fixed for redemption.

Notice of such optional prepayment shall be given at least thirty (30) days prior to the prepayment date by mailing to the registered owner of this Note a notice fixing such prepayment date and the amount of principal to be prepaid.

THIS NOTE may be assigned and upon such assignment, the assignor shall promptly notify the State Treasurer in the City of Columbia, South Carolina, by registered mail, and upon the surrender of this Note to the State Treasurer, either in exchange for a new fully registered note or for transfer on the registration records and verification of the endorsements made on the Payment Record attached hereto of the portion of the principal amount hereof and interest hereon paid or prepaid, and every such assignee shall take this Note subject to such condition.

For the payment of the installments of principal of and interest on this Note, as the same respectively mature, there are hereby pledged all revenues derived from paying patients at Whitten Village, and in addition thereto, and as further security for the payment of the installments of principal of and interest on this Note, there are hereby pledged, to the extent related in the aforesaid resolution of the State Budget and Control

Board, the revenues derived by the State of South Carolina from the taxes levied upon inheritances, gifts and estates of deceased persons.

The pledge of revenues derived from paying patients at Whitten Village is declared to be on a parity with the pledges heretofore made or hereafter to be made to secure the payment of the principal of and interest on Notes issued, or to be issued, on behalf of Whitten Village.

The pledge of revenues derived from the taxes levied by the State of South Carolina upon inheritances, gifts and the estates of deceased persons is declared to be on a parity with pledges of said revenues heretofore made or hereafter to be made to secure other obligations issued or to be issued pursuant to laws enacted by the General Assembly of the State of South Carolina.

The right is expressly reserved to issue additional obligations of the State of South Carolina to be authorized by legislation subsequently to be enacted and to be secured by a pledge on a parity with the pledge of revenues derived from the taxes levied upon inheritances, gifts and the estates of deceased persons.

IT IS HEREBY CERTIFIED AND RECITED that all conditions, acts and things required by the Constitution or Statutes of the State of South Carolina to exist, be performed or happen precedent to or in the issuance of this Note, exist, have been performed and have happened, and that the amount of this Note, together with all other indebtedness of the State of South Carolina, does not exceed any limit prescribed by such Constitution or Statutes.

THE STATE OF SOUTH CAROLINA.

WHEREAS, the South Carolina Mental Health Commission (the Commission) has presented an application to the State Budget and Control Board of the State of South Carolina (the Board) for the sum of One Million Dollars (\$1,000,000) to pay a portion of the cost of an administration building at the State Hospital; and

WHEREAS, the Board has considered said application and has, for itself, obtained the information needed to make the findings hereinafter made,

NOW, THEREFORE, BE IT RESOLVED BY THE STATE BUDGET AND CONTROL BOARD OF THE STATE OF SOUTH CAROLINA, AS FOLLOWS:

I.

The Board has ascertained, and hereby determines that a definite and immediate need exists for the improvements described in the application made on behalf of the Commission as follows: To pay a portion of the cost of constructing and equipping an administration building at the State Hospital, and that the application therefor should be approved.

II.

That the fees collected from paying patients of the State Department of Mental Health calculated both on the basis of the preceding 12-month period, as contemplated by Paragraph 3 of Section 1 of Act 1100 of the Acts of the General Assembly of the State of South Carolina, entitled "AN ACT TO AUTHORIZE THE ISSUANCE OF NOTES OR BONDS FOR MENTAL HEALTH FACILITIES; TO PRESCRIBE THE CONDITIONS UNDER WHICH THEY MAY BE ISSUED; TO PROVIDE FOR INVESTMENTS IN SUCH NOTES OR BONDS; AND TO PROVIDE FOR THEIR PAYMENT," Approved the 20th day of April, 1964, as amended by Act No. 485 of the Acts of 1965, (Act 1100), and on the basis of the available number of patients for the preceding 3-year period as contemplated by Section 4 of Act 1100, were as follows:

Such estimated revenue, based both on the basis of the fees collected during the preceding 12-month period contemplated by Paragraph 3 of Section 1 of Act 1100, and on the basis of the preceding 3-year period contemplated by Section 4 of Act 1100, will, if multiplied by the number of years for which the Notes herein provided shall be outstanding, result in the production of a sum equal to not less than one hundred twenty five per cent (125%) of the estimated aggregate principal and interest requirements of all Notes or Bonds now outstanding and now proposed to be issued for said Institution upon the approval of such application.

III.

The Board hereby approves such application and shall transmit to the Governor and State Treasurer a request for the issuance of Notes to the extent of \$1,000,000 on behalf of the State Department of Mental Health and in order to comply with the provisions of Section 3 of Act 1100 sets forth the following information:

1. The name of the State Institution seeking funds and the amount sought on the basis of the application filed with the Board is as follows:

SOUTH CAROLINA STATE HOSPITAL      \$1,000,000

2. The Board has made all findings required of it by Section 2 of Act 1100 and has not modified in any way the application made on behalf of the Commission.

3. The proposed maturity schedule of the Notes is as set forth in Schedule "F" attached to the application.

4. The anticipated interest cost for each year during the life of the Notes and the anticipated aggregate principal and interest requirements for the Notes are set out in full in said Schedule "F" attached to the application of the Commission.

5. It is proposed that the Notes to be issued be subject to redemption on June 1, 1968 and all subsequent interest payment dates in the inverse chronological order of the maturities of the principal instalments, in multiples of \$10,000, and at a redemption price equal to the par value of the principal amount so redeemed and accrued interest to the date fixed for redemption.

6. The number of paying patients of the South Carolina State Hospital at the time of application and the revenue derived therefrom during the preceding 12-month period were as follows:

State Institution Notes in the aggregate amount of \$1,000,000 should be issued as a single issue. Such issue shall consist of a single fully registered Note, more fully described as follows:

\$1,000,000 State Hospital Note, Series of June 1, 1967, dated as of the first day of June, 1967, payable in twenty (20) equal annual installments of \$50,000 each on the first day of June in the years 1968 to 1987, inclusive, bearing interest at the rate of five and one-half per centum (5-1/2%) per annum, from the date of delivery thereof (as established by the certification endorsed thereon), payable on June 1 and December 1 of each year, commencing December 1, 1967. Both the principal and interest are payable in legal tender by check or draft issued by the State Treasurer of the State of South Carolina to the registered holder of the Note.

The form of said fully registered Note shall be substantially as set forth in "EXHIBIT A" attached hereto.

The State of South Carolina reserves the right to effect the prepayment, on any interest payment date after December 1, 1967 of any portion of the indebtedness evidenced by said State Hospital Note, Series of June 1, 1967, that it may determine upon, in the inverse chronological order of the maturities of the principal installments, and in multiples of \$10,000, at a redemption price equal to the par value of the principal amount so redeemed and accrued interest to the date fixed for redemption.

If the option to redeem shall be exercised, notice of redemption shall be given to the holder of said Registered Note at least thirty (30) days prior to the prepayment date, by mailing to such holder a notice prescribing such prepayment date and specifying the amount of principal to be prepaid.

Payment of interest and installments of principal of said Note, and portions thereof (if the privilege of redemption be exercised) shall be effected by check or draft drawn by the State Treasurer to the order of the registered holder. All payments of principal shall be duly endorsed upon the Payment Record appended to said Registered Note.

V.

Said Registered Note shall be executed on behalf of the State of South Carolina by the Governor and State Treasurer. The Great Seal of the State of South Carolina shall be affixed thereto and the same shall be attested by the Secretary of State.

VI.

Pursuant to the authorization of Section 13 of Act 1100, the Board approves the private placement of the Note hereby authorized to be issued, to bear interest at the rate of five and one-half per centum (5-1/2%) per annum, from the date of the delivery of the Note (as established by the certification endorsed thereon), payable on June 1 and December 1 of each year, commencing December 1, 1967. Such Registered Note shall be sold to the State Budget and Control Board of South Carolina, as Trustee

of the funds of the South Carolina Retirement System.

VII.

For the payment of the principal of and interest on the Notes herein authorized, there shall be pledged the revenues derived from paying patients at the State Hospital and so much of the revenues derived by the State of South Carolina from inheritances, gifts, or estate taxes as may be necessary to meet the annual principal and interest requirements of said Notes.

VIII.

The State Budget and Control Board, in its capacity as the owner and holder of all Notes heretofore issued for the State Hospital hereby consents that the Notes issued pursuant to this Resolution shall be on a parity in all respects with the Notes heretofore issued for the State Hospital and Whitten Village, as well as on a parity with all other Notes hereafter to be issued for the State Hospital; and the State Treasurer is hereby authorized and empowered to place upon the face of each of all of said Notes heretofore issued a written statement evidencing this action.

IX.

The pledge of the revenues derived by the State of South Carolina from taxes imposed upon inheritances, gifts, and the estates of deceased persons, herein made to additionally secure the State Hospital Notes, Series of June 1, 1967, shall not be deemed closed, and obligations may hereafter be issued by the State of South Carolina (if authorized by appropriate legislative enactment) secured in whole or in part by a pledge of the revenues derived by the State of South Carolina from taxes levied upon inheritances, gifts and the estates of

deceased persons, on a parity in all respects with the pledges made to additionally secure obligations issued or to be issued for the State Hospital.

X.

A certified copy of this Resolution shall be transmitted to each of the State Governor and the State Treasurer, who shall, if they make the findings prescribed by Section 4 of Act 1100, approve this request and thereafter effect the issuance of the Notes herewith requested.

In addition to the installments of principal required to be paid as hereinabove set forth, the right is reserved to the State of South Carolina to prepay on June 1, 1968, and all subsequent interest payment dates, installments of principal in inverse chronological order, and in multiples of \$10,000 and at a redemption price equal to the par value of the principal amount so redeemed and accrued interest to the date fixed for redemption.

Notice of such optional prepayment shall be given at least thirty days prior to the prepayment date by mailing to the registered owner of this Note a notice fixing such prepayment date and the amount of principal to be prepaid.

THIS NOTE may be assigned and upon such assignment the assignor shall promptly notify the State Treasurer in the City of Columbia, South Carolina, by registered mail, and upon the surrender of this Note to the State Treasurer, either in exchange for a new fully registered note or for transfer on the registration records, verification must be made of the endorsements made on the Payment Record attached hereto of the portion of the principal amount hereof and interest hereon paid or prepaid, and every such assignee shall take this Note subject to such condition.

For the payment of the installments of principal of and interest on this Note, as the same respectively mature, there are hereby pledged all revenues derived from paying patients at South Carolina State Hospital, and in addition thereto, and as further security for the payment of the installments of principal of and interest on this Note, there are hereby pledged, to the extent related in the aforesaid resolution of the State Budget

and Control Board, the revenues derived by the State of South Carolina from the taxes levied upon inheritances, gifts and the estates of deceased persons.

The pledge of revenues derived from paying patients at the South Carolina State Hospital is declared to be on a parity with the pledges heretofore made or hereafter to be made to secure the payment of the principal and interest of notes issued or to be issued on behalf of the South Carolina State Hospital.

The pledge of revenues derived from the taxes levied by the State of South Carolina upon inheritances, gifts and the estates of deceased persons is declared to be on a parity with pledges of said revenues heretofore made or hereafter to be made to secure other obligations issued or to be issued pursuant to laws enacted by the General Assembly of the State of South Carolina.

The right is expressly reserved to issue additional obligations of the State of South Carolina to be authorized by legislation subsequently to be enacted and to be secured by a pledge on a parity with the pledge of revenues derived from the taxes levied upon inheritances, gifts and the estates of deceased persons.

IT IS HEREBY CERTIFIED AND RECITED that all conditions, acts and things required by the Constitution or Statutes of the State of South Carolina to exist, be performed or happen precedent to or in the issuance of this Note, exist, have been performed and have happened, and that the amount of this Note, together with all other indebtedness of the State of South Carolina, does not exceed any limit prescribed by such Constitution or Statutes.

IN WITNESS WHEREOF, the STATE OF SOUTH CAROLINA has caused this Note to be signed by the Governor of South Carolina and by the State Treasurer of South Carolina, and has caused

A RESOLUTION

MAKING PROVISION FOR THE ISSUANCE OF \$4,500,000 OF NOTES OF THE STATE OF SOUTH CAROLINA FOR THE PURPOSE OF RAISING MONEYS FOR THE THREE STATE INSTITUTIONS HEREINAFTER NAMED.

BE IT RESOLVED BY THE STATE BUDGET AND CONTROL BOARD OF THE STATE OF SOUTH CAROLINA:

PART I

FINDINGS OF FACT

Section 1.

As an incident to the adoption of this Resolution, the State Budget and Control Board of the State of South Carolina (the State Board) finds that the facts set forth in this Article are in all respects true and correct:

1. By the provisions of Statutes of the State of South Carolina, the Governor and the State Treasurer of South Carolina are duly authorized and empowered to issue Notes of the State of South Carolina, payable in the manner set forth in said Acts, and for State Institutions as follows:

(a) For the University of South Carolina, Part I of Act No. 491 of the Acts of 1965, \$2,000,000, to pay a portion of the cost of constructing a multi-purpose auditorium more fully described in Paragraph (2), Section 2, Part I of said Act.

(b) For Retarded Children's Habilitation Center, Act No. 284 of the Acts of 1963, as amended by Act No. 350 of the Acts of 1965 (Page 634 of the Acts of 1965), \$3,000,000 for facilities at said Center.

(c) For the Educational Television Commission, Section 3, Part V of Act No. 1019 of the Acts of 1966, not exceeding \$2,000,000 for constructing and equipping additional open circuit educational television stations.

Section 2.

It has been determined by the State Board that State Notes, pursuant to the said authorizations in the following amounts and for the purposes set forth above, should be issued

as of June 1, 1967 and sold as hereinafter provided, viz.:

For the <u>University of South Carolina</u>	\$2,000,000
For <u>Retarded Children's Habilitation Center</u>	\$1,500,000
For <u>Educational Television Commission</u>	\$1,000,000

Section 3.

While obligations have been incurred pursuant to the Acts above recited, the aggregate of Notes determined to be issued pursuant to this Resolution are within the limitations of said Acts.

Section 4.

This Resolution has been adopted for the purpose of making provision for the issuance, sale and delivery of the Notes for each of said institutions.

PART II

ISSUANCE OF NOTES FOR THE UNIVERSITY OF SOUTH CAROLINA

Section 1.

As an incident to the issuance of \$2,000,000 of Notes of the State of South Carolina for the University of South Carolina (the University), pursuant to Act No. 491 of the Acts of the General Assembly of the State of South Carolina for the year 1965, as amended (the Act), it is specifically found as follows:

The Trustees of the University have, in the manner prescribed by Section 5 of the Act, agreed to impose an admission charge upon all performances, contests or events which shall take place in the facilities under construction pursuant to the authorization of the Act, and to impose, in the manner prescribed by Section 6 of the Act, a student fee of two dollars and fifty cents per student per semester upon all students as defined by said Act, and have agreed that the said admission charge and the

student fee shall remain in effect for so long a time as shall be required in order to repay in full all sums to be paid by the State by way of principal and interest upon the Notes to be issued pursuant to the Act and notwithstanding that the period of time for which the admission charge and student fee be effective shall be of longer duration than the period of time over which the Notes shall be outstanding. Said student fee has been put into effect, to be effective as of the September, 1967 semester, and the Trustees have agreed that the sums to be raised from the student fee of two dollars and fifty cents, and such sums as may hereafter be raised from the admission charge to be imposed pursuant to Section 5 of the Act shall, from time to time, be remitted to the State Treasurer, in order that he in turn may cause the same to be credited against payments to be made by the State on account of the principal and interest of the Notes issued for the University.

The project authorized is now under construction, Note Anticipation Notes have been issued in anticipation of the issuance of the Notes herein authorized, and funds are required to the extent of the principal of said Notes to repay the Note Anticipation Notes and for costs incident to the construction of the project.

Section 2.

Pursuant to the authorization of Act No. 491 of the Acts of the General Assembly of the State of South Carolina for the year 1965, as amended, and in order to raise moneys to pay a portion of the cost of a multi-purpose auditorium now under construction at the University and to pay the \$500,000 of Note Anticipation Notes referred to above, the State Board hereby authorizes and empowers the Governor and the State Treasurer to issue \$2,000,000 of Notes of the State of South Carolina, to be

designated "SOUTH CAROLINA STATE NOTES (ISSUED FOR UNIVERSITY OF SOUTH CAROLINA MULTI-PURPOSE AUDITORIUM)."

Section 3.

The Notes shall be issued in fully registered form and as a single fully registered note, in the name of the State Budget and Control Board of the State of South Carolina, as Trustee of the funds of the South Carolina Retirement System.

Section 4.

The Notes shall be dated as of June 1, 1967, shall bear interest at the rate of five and one-half per centum (5-1/2%) per annum, from the date of the delivery thereof (as established by the certification endorsed thereon), payable on the first days of June and December of each year, commencing December 1, 1967, until the principal amount shall be paid in full, and shall mature in equal annual installments of \$100,000 each on June 1 in each of the years 1968 to 1987, inclusive.

Section 5.

The State of South Carolina reserves the right to effect the prepayment, on June 1, 1968 and all subsequent interest payment dates, of any portion of the indebtedness evidenced by said Notes, that it may determine upon, in the inverse chronological order of the maturities of the principal installments, and in multiples of \$10,000, at a redemption price equal to the par value of the principal amount so redeemed, and accrued interest to the date fixed for redemption.

If the option to redeem shall be exercised, notice of redemption shall be given to the holder of said registered note at least thirty (30) days prior to the prepayment date, by mailing to such holder a notice prescribing such prepayment date and specifying the amount of principal to be prepaid.

Section 6.

Payment of interest and installments of principal of said Notes and portions thereof (if the privilege of prepayment be exercised) shall be effected by check or draft drawn by the State Treasurer. Such payments shall be effected by the use of funds pledged for the payment of the principal and interest of the Notes. All payments of principal and interest shall be duly endorsed upon the Payment Record appended to said Registered Note.

Section 7.

The Notes shall be executed on behalf of the State of South Carolina by the Governor and State Treasurer. The Great Seal of the State shall be affixed thereto and the same shall be attested by the Secretary of State.

Section 8.

The form of the Notes as issued in fully registered form shall be as set forth in Exhibit B annexed hereto and made a part of this Resolution.

PART III

ISSUANCE OF NOTES FOR RETARDED CHILDREN'S HABILITATION CENTER

Section 1.

Pursuant to the authorization of Act No. 284 of the Acts of the General Assembly of the State of South Carolina for the year 1963, as amended by Act No. 350 of the Acts of 1965 (Page 634 of the Acts of 1965), and in order to raise moneys to pay the cost of constructing and equipping additional facilities at the Retarded Children's Habilitation Center and to pay certain Note Anticipation Notes issued in anticipation of the issuance of the Notes authorized herein, the State Board hereby authorizes and empowers the Governor and the State Treasurer to issue \$1,000,000 of Notes of the State of South Carolina, to be desig-
