EITHER WAY, I WANT TO REMIND THE LEADERSHIP OF THE CITY OF LOWELL AND OF THE LOWELL POLICE DEPARTMENT THAT THE EVIDENSE SUGGESTS VERY STRONGLY THAT PEOPLE SUCH AS **LOWELL P. D. SGT. JOSE TORRES** (aka **Chito**) HAVE BEEN INSTRUMENTAL IN THE PAST IN LOSING CRIMINAL RECORDS OF THAT SORT WHILE APPARENTLY ALSO HELPING THAT SORT TO GET BACK TO THE UNITED STATES.
