

Dental Plus network changes coming March 1

The provider network for the Dental Plus plan offered through the South Carolina Public Employee Benefit Authority (PEBA) and insured by BlueCross BlueShield of South Carolina will change effective March 1, 2016. PEBA's current Dental Plus provider network will convert to Blue Cross' network March 1. Blue Cross' network is larger than the current Dental Plus network and Blue Cross is actively recruiting dental care providers who participate only in PEBA's Dental Plus network.
