

REASONING RESEMBLES THE BIRTH RECORDING.
WHEN THE CHILD IS BORN IN A HOSPITAL OR IN A PLACE WHERE A PHYSICIAN OR MIDWIFE IS PRESENT, THE BIRTH RECORDING SHOULD BE MADE BY THE PHYSICIAN OR MIDWIFE.
IF THE CHILD IS BORN AT HOME, THE BIRTH RECORDING SHOULD BE MADE BY THE FATHER, HOUSEHOLDER, ETC., OR BY SOME OTHER PERSON WHO IS PRESENT AT THE BIRTH.
IF THE CHILD IS BORN AT HOME AND THE FATHER, HOUSEHOLDER, ETC., OR SOME OTHER PERSON WHO IS PRESENT AT THE BIRTH, DOES NOT MAKE A BIRTH RECORDING, THE BIRTH RECORDING SHOULD BE MADE BY THE PHYSICIAN OR MIDWIFE WHO ATTENDS THE BIRTH.
IF THE CHILD IS BORN AT HOME AND THE FATHER, HOUSEHOLDER, ETC., OR SOME OTHER PERSON WHO IS PRESENT AT THE BIRTH, DOES NOT MAKE A BIRTH RECORDING, AND THE PHYSICIAN OR MIDWIFE WHO ATTENDS THE BIRTH DOES NOT MAKE A BIRTH RECORDING, THE BIRTH RECORDING SHOULD BE MADE BY THE LOCAL REGISTRAR.
IF THE CHILD IS BORN AT HOME AND THE FATHER, HOUSEHOLDER, ETC., OR SOME OTHER PERSON WHO IS PRESENT AT THE BIRTH, DOES NOT MAKE A BIRTH RECORDING, AND THE PHYSICIAN OR MIDWIFE WHO ATTENDS THE BIRTH DOES NOT MAKE A BIRTH RECORDING, AND THE LOCAL REGISTRAR DOES NOT MAKE A BIRTH RECORDING, THE BIRTH RECORDING SHOULD BE MADE BY THE LOCAL REGISTRAR.
