Mr. Poore called the meeting to order and Mr. Wright gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to approve the minutes of April 19, 1977 Council meeting as mailed.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to go into Formal session.

On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to adopt an Amendment to Ordinance Number 2 on third reading.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to go back into Informal session.
