Dear Danny:

Lt. Governor Bryant and I had a text conversation yesterday about the Planned Parenthood funding issue. This is something I met with Governor McMaster about some two weeks ago.

To recap, on April 13, President Trump signed H. J Res. 43 repealing Obama's 11th hour mandate requiring states to fund PP with Title X monies.

The SC House and Senate were operating under the Obama mandate when the budget was passed; but that is no longer the case.

The strategy we recommend for defunding abortion is for the Governor to direct all Title X funding be distributed to the federally funded, community-based clinics in South Carolina that provide women's health care but now abortion in preference to organizations engaged in reprehensible activities, such as Planned Parenthood, a mega marketer of abortion that also has been involved in fetal organ trafficking. This strategy is possible with H. J Res 43 now in place.
