Good morning Lily,

I hope you are doing well! I wanted to reach out to you in regards to the Lieutenant Governor's possible presence at the LGOA's 2017 Senior P.R.E.P. (Planning and Resources for Emergency Preparedness) events.

The LGOA developed and maintains Senior P.R.E.P., a program designed to raise awareness of the importance of individual emergency preparedness for South Carolina's senior population, in partnership with the South Carolina Emergency Management Division (SCEMD) and Walgreens Company (see attached for brochure). This program provides accessible emergency preparedness information for older adults and adults with disabilities via all 114 Walgreens store locations across South Carolina.

Each year the LGOA coordinates two Senior P.R.E.P. kickoff events at selected Walgreens store locations. In the past, previous Lieutenant Governors have made appearances at these events to help promote this initiative, and senior citizen attendees were very grateful and appreciative of the opportunity to interact with the Lieutenant Governor himself. We are currently working to confirm the Senior PREP event dates for the 2017 year, however we wanted to check with you on the Lieutenant Governor's availability as we would really like for him to participate, if possible.

- ® June 16, 2017 or June 23, 2017 -Hurricane Awareness | Horry County (Myrtle Beach)
- ® September 22, 2017 or September 29, 2017 - National Preparedness Month/Flu Shot & Open Enrollment | Richland County (Columbia)

If you would like, I am happy to discuss this initiative and our public/private partnership with Walgreens further, and/or answer any questions you may have.

Please let me know your thoughts on the Lieutenant Governor's potential participation, and if any of these dates are feasible for his schedule so that we may plan accordingly. I appreciate your time and attention to this matter, and I look forward to hearing from you.
