Hope this email finds you in good health and well rested as the SC legislative process begins. I did see that the Governor did release the budget earlier this year; which hopefully meant you had some relaxation before the new year.

As you are aware Alvarez & Marsal's work with SCDHHS ended this past Fall. I believe the work we assisted Director Keck with has improved the accountability and transparency in budget and financial reporting within SCDHHS.

Last summer we visited about the concept of South Carolina developing a final approved budget document that could be submitted for the Government Finance Officers Association (GFOA) Distinguished Budget Awards program.
