

Woman charged with setting man on fire

A Laurens man is in the Augustus Burr Center this week and a woman under arrest after deputies say she lit the man on fire as he slept.

Deputies with the Laurens County Sheriff's Office arrested Angela Nicole Berry, 38, of Laurens early Friday morning on charges of attempted murder and second-degree assault. She had severely burned the victim.

Deputies were dispatched, along with officers from the Laurens Police Department, to a home on Rabon Road just after midnight Friday morning in reference to an assault that had taken place earlier on Steve Thompson Road.

when Berry threw an unknown substance on him, and the next thing he knew, he was on fire.

Deputies contacted EMS and related the victim's status.

Paramedics arrived and the victim was airlifted to the Augusta Burr Center.

Investigators went to the home on Eve Thompson Road, where they found Berry and questioned her about the incident. Investigators also noted that there were signs of a fire in the home.

Berry denied the accusations, but investigators said her statements didn't match up with the evidence they had gathered. Berry was placed under arrest and transported to the Johnson Detention Center for booking. She remained in the detention center with a \$10,000 bond as of Tuesday afternoon.

I want to know how i get a Law made . I want it called " The Billy Law " I want it where anyone who is in Jail on criminal domestic violence should have to be seen by a Doctor to see if they can be out . The woman who killed my father should had never been out. I feel the law System felled my father. she was let out on her 2nd afince .. 4 days after she was out my father called me and my brother and said " Nikki is not actting right I am thinking about coming off her bond " well i think when my dad confronted her with it she set this up . My father was a Good man . would do anythign for any one . if she needs something he would give it to her. no mater what it was . as I stood there holding my fathers hand on Dec 20th 2015 when he passed away at 6:15 pm I seen him take his last breath . it hurt so bad . my father was my Rock he was all ways there when i needed someone . i knew who to call on . and he was there.

again I am just wanting to know who i contact and how i go about making this law. My father is not here so i am his Voice . I want to put a stop to this from her getting out and for this not to happen to someone father . Please get back to me soon .
