It appears by the attached documents, hereby certified to be authentic, that **William David Weintraub** stands charged in Horry County, State of South Carolina, with the crime of **Weapons/Possession, Threatened or Attempted use of Weapon of Mass Destruction for Act of Terrorism, Resulting in Death** such offense having occurred on or about the 9th day of **October, 2013**. It has been represented to me that the accused was present in this State when the crime was committed and that he has fled from the justice of this State and is to be found in the State of Colorado.

Therefore, pursuant to the Constitution and Laws of the United States in such cases, I respectfully demand that **William David Weintraub** be apprehended, secured and delivered to an agent appointed herein.

I do hereby appoint and commission **Sheriff Phillip Thompson, Horry County Sheriff's Office**, or his duly appointed agent, to take custody of **William David Weintraub** from the appropriate authorities of the State of Colorado and convey him to the State of South Carolina, here to be dealt with according to law.


APPLICATION FOR EXTRADITION REQUISITION

NOW COMES, **JIMMY A. RICHARDSON, II**, SOLICITOR FOR THE FIFTEENTH JUDICIAL CIRCUIT OF THE STATE OF SOUTH CAROLINA, AND CERTIFIES:

- A. That **William David Weintraub**, is the name of the person for whom extradition is asked and that it is requested that **Sheriff Phillip Thompson** of the Horry County Sheriff's Office and/or his lawful designee(s) be designated to act as Agent(s) for the State.
- B. That in his opinion of the undersigned the ends of public justice require that the fugitive named herein, be brought to this State at public expense for trial.
- C. That the undersigned believes that he has sufficient evidence to secure the conviction of William David Weintraub.
- D. That the person named as Agent herein is a proper person, and said Agent has no private interest in the arrest of said fugitive.
- E. That there has been no former application for requisition for the said fugitive growing out of this or any other transaction.
- F. That **William David Weintraub**, the accused is under criminal arrest in the State of Colorado.
- G. That this application is not made for the purpose of enforcing the collection of a debt, or for any private purpose whatsoever, and if the requisition herein applied for be granted, the criminal proceedings shall not be used for any of said objects.
- H. The fugitive was arrested, was released, and has breached the conditions of bail. The crime of which the said fugitive stands charged is Weapons/Possession, threatened or Attempted use of Weapon of Mass Destruction for Act of Terrorism, resulting in death, a violation of Section 13-23-0715(1), Code of Laws of South Carolina (1976), committed in Horry County, South Carolina, on or about the 16th day May 2012.
- I. Such Fugitive has fled from the justice of this State.
- J. Such Fugitive has taken refuge in the State of Colorado.
- K. Such Fugitive was present in this State at the time such crime was committed.
- L. Below is a brief statement of the circumstances of the crime committed by such Fugitive, and details of the subsequent breach of conditions of bail, bond, pardon, parole, probation, or failure to comply with the sentence of the court, or the circumstances of his escape if he did escape from confinement:

On or about October 9, 2013, the defendant did contact The Sun News by telephone and email leaving messages stating he would carry out the threats for which he felt he was wrongly accused of in the past. The defendant had been reported for and charged between the years of 2007 through 2012, with making multiple threats to cause massacres, blow up schools, and kill public officials. The defendant did identify himself multiple times throughout the messages.

(1) in cases resulting in the death of another person, must be punished by death or by imprisonment for life or

(2) in cases which do not result in the death of another person, must be punished by imprisonment for not less than twenty-five years nor more than life
