EXTENSION OF BITUMINOUS RETREATMENT CONTRACTS
TO INCLUDE ADDITIONAL RESURFACING WORK

It is recommended that the Commission approve the action of the Department in extending existing bituminous retreatment contracts to include additional resurfacing work as follows:

Allendale, Bamberg, Barnwell & Hampton Counties:

Contract of J. F. Cleckley and Company - File Nos. 3.10951, 5.10951, 6.10951 and 25.10951 - extended to include an additional section of Project C-488 (File No. 3.488 - Allendale County) consisting of resurfacing of 0.20 mile on Road S-03-42 from US 301 to US 301; 1.10 mile on Road S-03-76 from US 321 to S-03-61; 0.70 mile on Road S-03-239 from S-03-641 to S-03-509; 2.30 miles on Road S-03-240 from S-03-509 to S-03-89; 0.40 mile on Road S-03-449 from S-03-76 to S-03-720; and 0.90 mile on US 278 from S-03-18 to S-03-47 (curb and gutter).

Estimated Cost of Extension \$376,731.41

Orangeburg County:

Contract of J. F. Cleckley & Company - File No. 38.104A, 38.105A, 38.10951 and 38.10952 - extended to include section of Project C-473 (File No. 9.473 - Calhoun County) consisting of the resurfacing of 2.50 miles on Road S-9-15 from US 176 to S-9-175.

Estimated Cost of Extension \$109,215.52

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

Contract of Sloan Construction Company, Inc. - File No. 40.504A - extended to include an additional section of State Project C-504A (File No. 40.504A) consisting of the resurfacing with asphalt concrete surfacing of 0.120 mile on Road S-2176 (Dunnagon Road) from Road S-930 to Road S-1279.

Estimated Cost of Extension \$ 11,543.50
