The ditches overflow when we get a big rain and lay full of water for weeks after. You can bet your dollar to a doughnut that the city doesn't have this problem. Again where is the Money going or in who's pocket.

I have checked with other residents in my area and there tax was \$16.00. Why is mine \$54.50???? I also discussed this with friends from other parts of the County and their taxes are different also. in my opinion we need to have some thing put out in writing to justify these charges or refuse to pay them.
