Gentlemen;

The City of Aiken needs your help.

As you know a portion of the funds designated by FEMA for PAX winter storm damages is earmarked for the State of South Carolina.

FEMA reps have said that this earmarked portion can be used for hazard abatement as deemed proper by the state.

We have identified a need for generators at three of our city buildings as well as 'pump-around' installations for our sewer lift stations to make sure we will not experience raw sewage release should another winter weather event deprives us of electrical power for a number of days.

Our estimated costs for these hazard abatement items totals in the neighborhood of \$400,000.

Can you help us obtain this funding to place these much-need hazard abatement installations at our city facilities?
