The U.S. House of Representatives pushed through a major water infrastructure bill on Thursday that includes aid for the water crisis in Flint, Michigan, even as Democrats objected to new provisions they said could strip environmental protections in California.

Congress Passes \$619B Defense Policy, Reform Bill

Congress has sent a series of major defense reforms to the president's desk following a Senate vote to pass a \$619 billion National Defense Authorization Act on Thursday, with changes to Pentagon bureaucracy, acquisitions and funding.

House Passes Gov't Funding Bill With Uncertain Senate Fate

The House of Representatives passed a measure to keep the federal government running into the first several months of President-elect Donald Trump's term Thursday, sending the bill to the Senate a day before funding runs out.

Lawmakers Unveil 1st Policy Proposal of Copyright Review

House Judiciary Committee Chairman Bob Goodlatte, R-Va., and Ranking Member John Conyers Jr., D-Mich., unveiled the first policy proposal to emerge from the committee's yearslong review of U.S. copyright law Thursday, which they said will modernize the U.S. Copyright Office and equip it to deal with the challenges of the 21st century.

Local Biosolids Ban Not Backed By Law, Facts, Judge Says

A California state judge has struck down a 2006 county measure banning the use of disinfected and dried-out sewage sludge on its land following years of litigation, saying the county ordinance runs afoul of state law and that the material poses no risk to residents.

The City Council of Portland, Oregon, approved a surtax Wednesday on publicly traded companies operating there whose CEOs earn at least 100 times as much as their median worker, making it the first U.S. city to employ the tactic aimed at combating wage inequality.
