In most agencies, it takes eighteen months to two years in order to fully train a

new latent print examiner. This is due to the fact that most internal trainers are also your bench analysts and they cannot commit 100% of their time to training. As a result, the length of the training program must be extended and the overall costs are significantly increased. Numerous agencies have advised that this method of training, including the salaries of the student(s) and the trainer(s), can actually cost their agency well over \$100,000.

RS&A has developed an intense 20 week training program for latent print examiner trainees which will result in graduates who are competent to perform supervised casework upon return to your agency. Prior to their academy graduation, they will have successfully completed testing regimens which are more difficult than the actual IAI Certified Latent Print Examiner Test. As soon as they have fulfilled the experience requirements, they will be ready to apply for certification through the International Association for Identification.

To be accepted into the academy, all applicants will have to meet stringent educational and ethical standards, along with passing a background investigation, and complete a visual acuity examination that is specifically designed to determine if they possess the natural skills to become a latent print examiner. Why? Because we don't want to waste anyone's time or money! Through our past experiences, we have determined that it really does not matter how hard a person is willing to work at becoming a latent print examiner, if they cannot discern what they observe, they cannot do the job.

The academy will be held at the Southern Regional Public Safety Institute, which is located on the grounds of Camp Shelby, a state owned and operated Joint Forces Training Facility for military personnel and law enforcement. Camp Shelby is a few miles south of Hattiesburg, MS and is just one hour north of the beautiful Mississippi Gulf Coast.
