

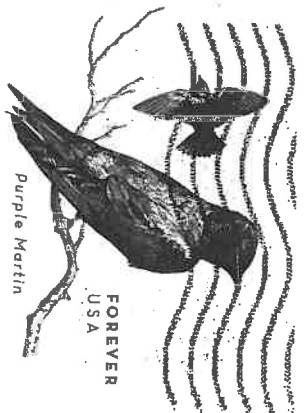


Thank you for contacting our Agency for information to assist you with a "Fresh Start" when you are released from the South Carolina Department of Corrections.
