**Associated Press:** Ethics board: Governor gets luxury box only for business

Gov. Nikki Haley can watch the University of South Carolina Gamecocks from a free luxury football suite only if she is conducting state business, the State Ethics Commission decided Wednesday. The commission's advisory opinion is a revision from last September, when the board unanimously said the university can continue its longstanding practice of providing free tickets to the box to whoever occupies the governor's mansion, calling it a gift to the office rather than Haley herself. While last fall's opinion said state business - such as courting company executives or hosting out-of-state dignitaries - should be a priority for the 16 tickets, it allowed for personal use. "A caveat we put in the opinion recognized that sometimes there won't be a big company you're trying to woo to South Carolina that's going to need these tickets," said agency attorney Michael Burchstead, referring to a paragraph that read, in part, "we are not advocating for the tickets to go to waste."

**NOTE:** The governor personally attended two of six home games last year and three of seven in 2014, said Haley spokeswoman Chaney Adams. Like previous administrations, Adams said, Haley has used the suite for state business "because there's no better way to showcase the great things going on in our state." Haley attorney Butch Bowers, who had no objection to the revised opinion, said the box is sometimes used for state business without Haley attending. But the governor's office couldn't detail who has used the suite or why.

Gov. Nikki Haley can continue to use University of South Carolina season football tickets and keep access to Williams-Brice Stadium's executive suites, but it must be for state-related business, the State Ethics Commission ruled Wednesday. The commission revisited an opinion from September that determined the Governor's Office could use the tickets for any purpose — as long as the priority is on state-related matters. Ethics Commission attorney Michael Burchstead said the tweak in the rules came after Commissioner Frank Grimball asked for the opinion be reconsidered. "Rather than saying 'using the tickets for state-related purposes is a priority,' the opinion states these tickets need to be used for state-related purposes, period," Burchstead said. Grimball said the opinion didn't go far enough. He argued that allowing the governor's office to use the tickets for any state-related business — and not specifically for economic development — would allow other state offices and municipalities to follow suit. He called the allowance vague in its scope.

**NOTE:** Haley's office said the governor was following the previous pattern of governors showcasing the university football team. "Like previous administrations, the office of Gov. Nikki Haley has used the University of South Carolina's executive suite for state-related purposes, including economic

development and business recruitment, because there's no better way to showcase the great things going on in our state," Haley spokeswoman Chaney Adams said.

If there's a way to tiptoe toward an endorsement of Donald Trump, South Carolina Gov. Nikki Haley found it on Wednesday when she arrived in Cleveland to attend the Republican National Convention. Speaking to the Palmetto State's delegates, Haley never uttered Trump's name. But she urged the Republican Party faithful to vote for him by vilifying his likely Democratic foe, Hillary Clinton.

"President Obama was awful the last eight years — a President Clinton would be disastrous," Haley told the delegates, who murmured in agreement over their bacon-and-eggs breakfast. Haley urged the South Carolina contingent to help get the message out that "a no vote in November is a vote for Hillary Clinton." Haley did not address her own misgivings about Trump, but it's no secret that she is not a fan of the brash New York real estate mogul. The South Carolina governor has repeatedly cautioned against Trump's racially tinged rhetoric. In her most high-profile remarks — the GOP rebuttal to President Obama's State of the Union speech in January — Haley recounted her own story as the daughter of Indian immigrants. She called on Americans to reject "the angriest voices," a clear rebuke to Trump's anti-immigrant statements and positions. "No one who is willing to work hard, abide by our laws, and love our traditions should ever feel unwelcome in this country," she said in that speech.

Is this presidential election about electing Donald Trump, or defeating Hillary Clinton? Republicans are divided on this question and South Carolina delegates are no exception. As it turns out, the Palmetto State's highest-ranking elected officials are distances apart. Gov. Nikki Haley and Lt. Gov. Henry McMaster spoke back-to-back at Wednesday morning's S.C. delegation breakfast. Haley, who endorsed U.S. Sen. Marco Rubio of Florida during the presidential primary, didn't say Trump's name once in her remarks. "A 'no' vote in November is a vote for Hillary Clinton," said Haley, who also told delegates she was in Cleveland "to support all of you." McMaster, who delivered a nominating speech for Trump at the Republican National Convention the night before, immediately followed Haley with strong words for fellow delegates who have not yet embraced the party's candidate for commander-in-chief. "I know that not everybody here was for Donald Trump," McMaster said. "He might not be the one for you. But as of last night, he is. He is the nominee of our party. "We have to say we're behind him," he continued, "like we do with our other candidates." None of this is really a tectonic plate shift.

Governor Nikki Haley is calling for unity behind GOP nominee Donald Trump. The Palmetto State's chief executive met with state delegates, alternates, and guests in Cleveland at a breakfast Wednesday morning. "He's our guy," said Eddie Taylor. "Senator Scott actually endorsed him. Said it's time for those folks that are not necessarily behind him at first to rally." The delegates, who have gone to several different convention events throughout the week, sent video to WIS of Haley

speaking at the breakfast. She was joined by Trump endorser Sen. Tim Scott and Lt. Gov. Henry McMaster, who helped put Trump's name into nomination, also spoke with South Carolina delegates today. "They were talking about all the reasons that we need to get unified now so that we can win in November," said Cindy Costa. "They were encouraging and motivating." Gov. Haley urged voters to get to the polls. She warned delegates that a "no" vote would be a vote for Hillary Clinton. "Nikki Haley never mentioned the name Donald Trump," said Jerry Rovner. "But she said support the Republican Party. So, it was noted by everybody that she didn't say his name." Gov. Haley told state delegates that bringing about change means being part of the solution and that means making sure everyone understands the importance of voting.

The verdict is in from Texans in Cleveland: Indiana Gov. Mike Pence is not exciting. But in a year of bombast and rancor, that's actually good. "He's not flamboyant, but he's not dangerous. There's a comfort level there," David Barton said about Donald Trump's running mate. "I don't think he's going to say anything that's going to get him in trouble." Barton, a prominent Texas conservative who ran a pro-Sen. Ted Cruz Super PAC and knows Pence personally, sees Pence as a Sherpa — someone who can guide Trump through the labyrinth of D.C. politics and policy. But Barton says it'll be up to the campaign to determine whether Pence can move the needle with conservatives wary of Trump. "How they use him, where they use him, what they do with him, what message they have him carry." Voters will get a glimpse of that Wednesday night, when Pence is set to take the stage at the Republican National Convention and introduce himself as Trump's vice presidential pick.

**NOTE:** "People will think, 'This guy could be president from day one,'" said Grant, 29, a ninth-grade geography teacher. But Grant, who is black, was one of a few delegates who said Trump missed a chance to broaden the GOP's appeal to racial minorities. "I would have been overjoyed if he had gone with someone like Nikki Haley," he said, referring to the South Carolina governor, a child of immigrants from South Asia's India.

CSX will bring a rail-to-truck shipping terminal to Edgecombe County, connecting eastern North Carolina to state ports and creating a projected 1,500 jobs throughout the state, Gov. Pat McCrory and railroad executives said Tuesday. The Carolina Connector hub built along CSX rail lines will fill an estimated 500 to 550 acres of land between Battleboro and College roads south of U.S. 301 in Rocky Mount. Jennifer Lantz, executive director of the Wilson Economic Development Council, said the project will also benefit to Wilson County. "This is great news for North Carolina and great news for the Rocky Mount area," McCrory said during a news conference following a public announcement at N.C. Wesleyan College's Dunn Center. "The Carolina Connector is something we wanted in North Carolina, and we finally achieved that goal. It's going to be a game-changer for North Carolina and especially eastern North Carolina."

**NOTE:** The governor said other locations in the Tar Heel State were considered for the intermodal hub and officials held off competition from South Carolina to secure the project. McCrory alluded to a friendly rivalry for economic development projects with fellow Republican Gov. Nikki Haley. "We wanted this major intermodal facility in North Carolina," McCrory said. "It's going to be extremely important not only to the Rocky Mount area, it's also going to be important to the rest of eastern North Carolina, to Wilmington and also to Charlotte. There's a connectivity here between the west and the east that's going to be extremely important."

The Republican Party may have nominated Donald Trump, but some South Carolina delegates are discouraged by what they describe as enduring divisiveness and negativity at the Republican National Convention. Without some quick healing in the confab's closing days, they fear, the party that has been fractured by a brutal primary season may have a hard time winning the general election - or surviving. "We are not going to win simply by demonizing Hillary, as much as she warrants derision," state Sen. Tom Davis, a libertarian-leaning lawmaker, told The Associated Press from



Cleveland. "We need to offer a positive message on what we are about, too." Davis spoke a day after impassioned floor speeches from the likes of New Jersey Gov. Chris Christie, who on Tuesday night effectively put Hillary Clinton through a trial-by-delegates "for her performance and her character."

Political candidates can use donations to pay their company or a family member, as long as the campaign services are legitimate and the cost is reasonable, the State Ethics Commission said Wednesday. The board's unanimous opinion applies only to future spending. It is not retroactive. Basically, donor-paid services "can't be a sham," said agency attorney Michael Burchstead. The advice should be common sense, but it's important to give guidance to candidates the agency oversees, he said. At issue is a law barring candidates and officeholders from using donations for personal benefit. While noting the law isn't specific, the opinion presumes legislators did not intend an outright ban on payments to candidates' businesses, family businesses or individual family members.

"If read too stridently, it can lead to some absurdities in application," the opinion reads. "If a candidate or his family owns a printing shop, a catering business, or a cleaning service, we do not read the ethics act as forcing the candidate to employ the services of a competitor." But the commission also recognizes such payments are ripe for abuse.

Candidates running for office in South Carolina can continue to use campaign funds to pay for work done through their own companies or businesses run by family members, the State Ethics Commission ruled Wednesday. The ruling comes after Attorney General Alan Wilson in December issued a non-binding opinion also allowing the expenses. Ethics Commission attorney Michael Burchstead said the ruling is was meant to give guidance to those who are under the group's jurisdiction. The commission covers those working or running for office at any level outside of the General Assembly, including governor, lieutenant governor, lobbyists and other elected positions. Burchstead stressed that candidates must use legitimate businesses and pay market value for services.

A former South Carolina House member spending three years in federal prison for money laundering has been disbarred. The state Supreme Court on Wednesday revoked Thad Viers' law license. It had been suspended since 2012, when Viers was charged with harassing an ex-girlfriend. In 2015, Viers pleaded guilty to money laundering for helping a construction company owner hide assets. Viers is currently in federal prison. He can apply to get his law license back once he completes his prison sentence. The Supreme Court would have to approve his application. Viers served in the House for a decade and was a rising Republican star before his harassment arrest.

The S.C. Supreme Court on Wednesday disbarred former state Rep. Thad Viers, a Republican from Horry County, for charges he faced in 2012 in connection with his ex-girlfriend as well for a federal money laundering charge in 2014. Viers is now serving time in a federal prison in Hopewell, Va., on money the laundering charges, which were unrelated to his personal problems. He is due to leave prison in June 2017. Once Viers, 38, of Myrtle Beach, had punched all the right tickets to ascend the Republican ladder of success. As a young teen, he was a page to the late Sen. Strom Thurmond, R-S.C., graduated from The Citadel in 1999, did research for the conservative Heritage Foundation think tank and was elected to the S.C. House of Representatives in 2003.

Republican New Jersey Gov. Chris Christie is standing by his friend and mentor who pleaded guilty to a bribery scheme involving the powerful transportation agency Christie appointed him to lead. Christie

said Wednesday that David Samson, who acknowledged using his position to pressure United Airlines to reinstate a flight that benefited him, is an "extraordinary person" and is "my friend and always will be." Christie made his remarks in Cleveland, where he's supporting presidential nominee Donald Trump at the Republican National Convention. Samson is a former New Jersey attorney general who headed Christie's transition team. Christie appointed him chairman of the Port Authority of New York and New Jersey, which runs area bridges, tunnels and transit hubs, in 2011. Samson admitted last week that he pressured United to reinstate a weekend flight between Newark, New Jersey, and South Carolina, near his second home. His sentencing is scheduled for October.

Dylann Roof's attorneys want a federal judge to bar evidence from his death penalty trial and withhold those details from the public. They plan to file a motion to suppress evidence that cites Roof's rights to be free from unreasonable searches under the Fourth Amendment and to not incriminate himself under the Fifth Amendment. But the filing would contain pieces of the evidence: a transcript, three videos and four other documents. The lawyers fear that making them public "could affect the court's ability to select an impartial jury and conduct a fair trial in this high-profile (capital) case," so they asked to make the request under seal.

The number of South Carolina children dying from abuse and neglect increased last year, according to the state Department of Social Services. DSS reported Tuesday that there were 28 deaths from abuse or neglect in 2015 compared with 22 deaths in 2014 and 25 in 2013, The Greenville News reported (<http://grnol.co/29V3Gzb> ). "Anyone who has worked in child welfare knows that the hardest part of a caseworker's job is learning of and responding to child fatalities that result from abuse and neglect," DSS Director Susan Alford said in a statement to The Greenville News. The state agency also said that the number of children served by the agency as a result of an indicated report of abuse or neglect increased to more than 20,000 last year. That was up from nearly 17,000 in 2014. According to department officials, most of the increase is because of a new, centralized reporting system.

The number of South Carolina children dying from abuse and neglect increased to 28 last year, the state's child welfare agency reported Tuesday. The State Department of Social Services also says that the number of children served by DSS as a result of an indicated report of abuse or neglect increased to 20,309 in 2015 from 16,794 for 2014. The number of fatalities as a percentage of all children served by the agency remained about constant from 2014 to 2015, DSS reported.



Tuesday's numbers, posted to the agency's website, compare to 22 children who died in 2014, 25 in 2013 and 14 in 2012, according to DSS. The agency, until Thursday, had reported 24 deaths in 2013 but said that number was in error.

Three more Zika cases among South Carolina residents have been reported over the past two days, bringing the state total to 21 confirmed cases. The S.C. Department of Health and Environmental Control reported on Wednesday that 20 patients contracted Zika when they traveled to impacted areas, and tested positive when they returned. The other case involved a resident who had sexual contact with someone who acquired the Zika infection while traveling abroad. The Zika virus is transmitted by the *Aedes aegypti* and *Aedes albopictus* mosquitoes — both of which are found in South Carolina. There is no evidence that they are spreading the disease locally. Only one out of every five patients ever actually get sick. Usually, the virus comes and goes within a week.

Ambulance workers in Lexington County will be getting to some calls faster – and to others, slower – due to a new 911 system being rolled out. "But what I do know what remains unshakable is my faith in the men and women here." Cruz was slated to deliver a prime-time convention speech, but no endorsement was expected. At a rally with some 900 delegates, donors, GOP officials and supporters at a lakeside restaurant, Cruz never mentioned Trump's name during an appearance billed as a "thank you" event for supporters.

**Associated Press:** Federal immigration court backlog tops 500,000 pending cases

The backlog in the federal immigration court system has eclipsed half a million pending cases, The Associated Press has learned. The Justice Department's Executive Office for Immigration Review said Wednesday there are now 500,051 pending immigration cases in the agency's courts. The backlog has been steadily rising in recent years as the number of unaccompanied children and people traveling as families have been caught crossing the Mexican border illegally. Since 2011 more than 200,000 cases have been added to the court's docket and backlog is likely to continue growing. More than 51,000 people traveling as families and more than 43,000 unaccompanied children, mostly from Honduras, El Salvador or Guatemala, have been caught crossing the border illegally since the start of the budget year in October. Cases of newly arrived immigrants facing deportation have been made a priority, but the backlog still means that many immigrants are likely to face years long delays before a judge makes a final decision on their cases. And while people are waiting to go before a judge, their case could dramatically change, for good or bad.

**Associated Press:** Turkey declares 3-month state of emergency after failed coup

Turkey's president on Wednesday declared a three-month state of emergency following a botched coup attempt, declaring he would rid the military of the "virus" of subversion and giving the government sweeping powers to expand a crackdown that has already included mass arrests and the closure of hundreds of schools. President Recep Tayyip Erdogan, who was accused of autocratic conduct before the insurrection, said the measure would counter threats to Turkish democracy. Possibly anticipating investor jitters, Erdogan criticized Standard & Poor's for downgrading its credit rating for Turkey deeper into "junk" status and said the country would remain financially disciplined. The president did not announce details, but the security measure could facilitate longer detentions for many of the nearly 10,000 people who have been rounded up since loyalist security forces and protesters quashed the rebellion that started Friday night and was over by Saturday.
