A special meeting of County Council of Charleston County was held on the 16<sup>th</sup> day of July, 2009, at 7:45 p.m. in Council Chambers, Second Floor, Lonnie Hamilton, III Public Services Building, 4045 Bridge View Drive, Charleston, South Carolina.

Present at the meeting were the following members of Council: Teddie E. Pryor, Sr., Chairman, who presided: Colleen Condon; Henry E. Darby; Curtis B. Inabinett; Joe McKeown; A. Victor Rawl, Dickie Schweers. Council Members Elliott Summey and Paul Thurmond were absent.

Also present were: Allen O'Neal, County Administrator; and County Attorney Joe Dawson.

The Clerk reported that in compliance with the Freedom of Information Act, notice of meetings and agendas were furnished to all news media and persons requesting notification.

An Ordinance accepting the transfer of Authority to the Board of Election and Voter Registration was given second reading by title only.

The vote being seven (7) ayes and two (2) absent, the Chairman declared the Ordinance to have received second reading approval.

A report was read from the Planning Committee under date of July 16, 2009 that it considered the information furnished by Allen O'Neal., County Administrator, and

Dan Pennick, Director of Zoning and Planning, regarding a proposed Zoning and Land Development Regulations Ordinance Amendment. It was stated that Charleston County Council held a public Hearing on the proposed text amendments prior to the scheduled Planning/Public Works Committee.

Committee recommended that Council approve and give first reading to an Ordinance on proposed text amendments to the Charleston County Zoning and Land Development Regulations Ordinance dealing with Transitional Provisions; Use Tables; Use Conditions and Terms and Uses Defined.

Mr. Pryor moved approval of Committee recommendation, seconded by Mr. McKeown, and carried. Ms. Condon and Mr. Rawl voted nay.

An Ordinance amending the Zoning and Land Development Regulations Ordinance was given second reading by title only.
