ONLY A PICTURE. I CAN SAY AS A MOTHER HE HAS LEARN FROM THE MISTAKE.THIS IS ALL I CAN DO FOR HIM NOW I CANT AFFORD TO HIRE A LAWYER. WE ARE GETTING OLDER AN NEED TO TRY AND GET HIM BACK HOME. I AM 69 YEARS OLD HAS A FEW HEALTH PROBLEM,HIS FATHER IS 72 YEARS A HANDICAP DISABLE VET WITH CANCER BROUGHT ON BY AGENT ORANGE FROM VIETNAM.FRIST LUNG CANCER AND NOW HE HAS LIVER CANCER HE IS FIGHTING HIS SECOND BOUT WITH CANCER.FIGHTING WITH CANCER SINCE 2005. I THINK MY SON HEALTH IS STARTING TO GO AS WELL FROM WHAT HE TELL ME WHEN I TALK TO HIM. HE WANTS TO BE IN HIS LITTLE GIRL LIFE BEFORE SHE GETS MUCH OLDER AND SHE DESERVE TO HAVE A DADDY. SHE WANTS TO SEE HIM VERY MUCH. I AM SURE HE WILL DO THE RIGHT THING FOR HIS DAUGHTER. HJS NAME IS MARION WILLIAM BENTON #243034 HE AT BROAD RIVER CORRECTIONAL HE HAS NEVER HAD A PCR BOND TO TRY TO GET BACK IN COURT.

AND I KNOW AS A MOTHER HE WILL DO THE RIGHT THING IF HE CAN GET ANOTHER CHANCE.
