PENALTY APPEAL PROCESS

Delinquent penalty fees for vehicle registration are required by Section 56-3-840 of the S.C. Code of Laws. The requirements for vehicle registration are specified in Section 56-3-610 and 56-3-110. Fees are subject to change by an Act of the S.C. Legislature. Any owner who feels the penalty paid is not in accordance with the laws has the right to appeal the fee. Complete the front portion of this form and return it with a copy of the vehicle registration and any supporting documentation to the address indicated.

RENEWAL OF VEHICLE REGISTRATION

South Carolina law requires vehicle owners to renew their registrations before the expiration date. The following is the schedule provided by law for assessing late registrations.

1 – 14 days late	\$10.00
15 – 30 days late	\$25.00
31 – 90 days late	\$50.00
Over 90 days late	\$75.00

NEW VEHICLE OWNERS
AND PERSONS MOVING FROM ANOTHER STATE

South Carolina law requires new vehicle owners and persons moving from another state to register their vehicles within 45 days. The following is the schedule provided by law for assessing late registrations.

46 – 60 days late	\$10.00
61 – 75 days late	\$25.00
76 – 135 days late	\$50.00
Over 135 days late	\$75.00
